Dear Captain Lao:

The Bolo Battalion, Municipal District of Masin, Province of Lanao, purporting to be a guerrilla organization under your nominal control is not favorably considered for recognition as an element of the Philippine Army.

A set of general requirements for guerrilla recognition, established by General MacArthur during the liberation of the Philippines, has been used as a guide in considering the record of this unit. After careful investigation and full consideration of all available substantiating records and testimony of witnesses having pertinent knowledge, recognition of this guerrilla unit is not deemed to be warranted because of the reasons mentioned below:

- a. The unit was not maintained satisfactorily in the field in opposition to the enemy.
- b. Many members apparently lived at home, supporting their families by means of farming or other civilian pursuits, and assisted the guerrilla unit on a part time basis only.
- c. Members of the unit did not devote their entire effort to military activities in the field to the exclusion of normal civilian occupation and family obligations.

It is requested that you comply with the provisions of Executive Order Number 68, by the President of the Philippines, dated 26 September 1945, copy attached.



1. Disapproved.
2. Unit was not maintained satisfactorily in the field in opposition to the enemy.

3. Many members apparently lived at home, supporting their families by means of farming or other civilian pursuits, and assisted the guerrilla unit on a part time basis only.

4. Members of the unit did not devote their entire effort to military activities in the field to the exclusion of normal civilian occupation and family obligations.

5. According to statement of Colonel Fertig, Bolo Units, when used, served with the understanding that no compensation would be given. Colonel Fertig has also stated that all units in Mindanao, deserving of recognition, have already been recognized under the 10th Military District.

SUBJECT: Guerrilla Affairs Bolo Battalion, Lanao Military Sector, 81st Division.

TO : GUERRILLA AFFAIRS SECTION G-3, AFWPSPAC, APO 707.

Reference: Sequence No. C-3282

It is advised that my letter, "SUBJECT: Bolo Battalions, Lanao" dated 28 March 1946, should be read in connection with this report. There is no question that the "Bolo Battalions" were organized by General Fort, but it is my contention that they fought little if any. It is possible that they burned a few bridges as reported by Datu Magarang Manungco in this report. There is no reference to an overall command headed by Datu Busran Kalaw as he claims in other statements. The Datu Magarang claims full credit for defeating the Japanese at Tamparan just as Datu Busran. 7

Recommendation - It is recommended that this request for recognition be disapproved since such Moros who had arms and assisted in the resistance movement are duly incorporated in the rosters and were recognized as a part of the 10th Military District, but such action should not mitigate against recognition of any meritorious action by the bolo battalions, prior to the surrender.

SUBJECT: Determination of Status
 TO : Adjutant General HPA, Manila,

1. Information is requested as to what action should be taken in the way of compensation to these Civilian Leaders of Lanao who were employed and sworn to in accordance with the MOHAMMEDAN WAY of taking oath, into the services of the 81st Div. USAFFE, under the command of Brigadier General GUY O. FORT.

2. The subject personnel were organized as BOLO BATTALION Unit upon instruction of the Commanding General of Lanao Military Sector with the consent and approval of MAJOR GENERAL WILLIAM SHARP Commanding General of VISAYAS-MINDANAO USAFFE.

3. The undersigned was appointed by Brigadier G.O FORT, Commanding General of Lanao Military Sector on or about February 1942, to organize the BOLO BATTALION with the following primary missions.

- a. Guarding the beaches in order to give a timely warning to our own Forces in case of enemy landing.
- b. To act as Labor Battalion when so desired.
- c. To guard bridges and roads and check the 5th column activities, and
- d. To guard ammunitions and supplies and other military installation in rear.

4. The undersigned being directly incharge of the said organization was made to understand and in turn transmitted to the men that they were entitled to pay and allowances to be determined later by the USAFFE GENERAL Headquarters, but due to lack of facilities in communications and transportation, the matter has not been determined.

5. The above request is made in the interest of these people who willingly sacrifices themselves in obedience to the order and instruction of MAJOR GENERAL SHARP.

6. It is to be stated in this connection that Major GENERAL SHARP was actually present in a MASS induction of Maranao Leaders and followers together with Brigadier GENERAL FORT, sometime in the first week of March, 1942, at Marantao, Lanao and the Commanding General informed the Maranao Leaders that whatever services has and will be rendered by them will be duly compensated by the United States and Philippine Governments.

7. Attached are partial roster of men in the Municipal District of Masiu, that actually served up to and including the date of General Surrender of Lanao Force on 27, May '42.

8. The different Municipalities and Municipal Districts each have organized able bodied men under the Leadership of each District Mayor and did actually served up to 27, May, 42, the date of the Surrender of Lanao Sector Force to the enemy.

Immediate action on the matter is early requested.

Sir:

I am submitting herewith the Historical events and activities which my organization had accomplished before and after the surrender of the Army Forces this province.

On 1st February, 1948, General G. C. FORT, organized the 81st Div with Captain Mamerinta Lao in the province. On 10th February, 1948, he went to Tamparan and held a meeting with all the Municipal District Mayors and other leading Datus of the Bual area. In the meeting there were enumerated organizations and areas were divided among Municipal District Mayors and other leading Datus. My organization was assigned to guard the whole area of our District that is comprising or rather covering from the Tamparan Maguing-Masiu and Gata boundaries and along the lake shore of the western side of Gata, Lanao. All my leaders were posted in their respective areas and full instruction was given to them to defend their areas.

On 21, February, 1948, all post were inspected by General G.C. FORT with American Col. from Camp Parang and Filipino Col. from Malabang with their names not known to us and Captain Mamerinta Lao. General G.C. FORT therefore made some corrections on the placing of our defense area.

At about the end of February and up to the 1st week of April 1948, we received orders that the guarding will be at Tamparan to be done by alternatives between Municipal Districts. We have guarded for four(4) times thru rotations. In this guarding, they were mostly done by the Municipal Districts of Tamparan and Gata, they being near the Camp.

On March 1948, guarding was still going on and order was received to collect two (2) sacks of clean rice to every leaders and to be placed in hiding places accessible by retreating armies from the firing line. All my leaders were able to give and were properly placed in accordance with the instructions. All rice were eaten by retreating armies and we even sacrificed by giving our own personal food to them as they arrived to us asking for protection and giving them food.

On 18 April, 1948, all my men were ordered to bring all government properties coming from Bansalan being brought by the S. S. Blanco and other launches to Tamparan and same were brought to Siwagat. After delivering all government properties to Siwagat report was received that Japp had reached at Gemasi on 28 April, 1948 and all our men were posted near the National Highway from Gata-Tamparan to Gata-Masiu boundaries.

After posting all men along the National Highway, the riot of the men evacuated their wives and children to Cambong near the forest and returned to their respective defense posts.

On 28 April, 1948, at about 12:00 PM Captain Whatt with some American Officers and around 1,000 soldiers joined our guards along the road and established their defense line side by side with my men. They have extended their defense in the northern bank of Gata River, the armies supposed to be coming from the southern bank of the river following the National Highway. At about 6:00 PM, Col. Meidas arrived and conferred with Capt. Whatt and other Officers and later the men were assembled and withdrew and went to Carootan, Bobong, Lanao. Before the armies left Col. Meidas ordered us to burn all the bridges so that the tank of the Japs if any can not cross the rivers. After the armies left we all burned the bridges.

From 29 to 30 April, 1948, there were plenty of retreating armies coming from Lambatan and nothing was plundered nor had died in our area as all were duly protected and directed to proceed to Camp Mambayag. The established camp of the army was near the S. S. Blanco.

After the Japs passed there were plenty of armies that arrived from the east coming from Davao, Camp Parang and Cotabato and joined with Major Hill and Capt. Lim and Capt. Anieta. After compiling all the remnant soldiers who were separated from their mother units formed a regiment at Siwagat under the above named Officers and established their camp at Siwagat. Later on and order from General Fort arrived that they are to surrender to Dansalan. All the members of the Bolo Bn were again called to help them bring their supplies and rations from Siwagat and Taloan to Lanuk where they have camped while on way to Dansalan. After accomplishing the works given to us all returned to our respective homes.

On May 16, 1942, the Army under General C. O. Fort, surrendered to Dansalan. After the surrender all people of the provinces tried to secure arms thru following routes crossed by the evacuated armies and tira pumassi from Maranos who have first traced routes crossed by evacuating armies. Arms were thrown by the evacuating armies and some were found buried.

On 12 July, 1942, when many had already secured arms, the Japs attacked Masiu and I again assembled my men and fight the Japs at Talagian the boundary between Gata and Masiu. After a half day fight the Japs were repulsed and forced to withdraw.

On 20, July, 1942, because the Japs had felt a heavy firing at Talagian during the first fight on 12, July, 1942, the Japs tried to attack us and sorry to state that the Japs had never penetrated on our defense. The Japs then were forced to retreat to Masiu beach and took the launch and returned to Dansalan.

Beginning 20, 1942, the Japs Government requested the surrender of arms. Among my men none had surrendered as I have ordered them not to surrender any arm. None of my men was able to give. I advised them that they must not be afraid of the Japs and we must not listen to their propagandas as transmitted by their collaborationist.

On 12, Sept., 1942 the Japs attacked Tamparan. Believing that they will not be finished and miscalculating the strength and bravery of the brown people like the maranos, which were organized in to Bolo Bn, therefore jointly fight the Japs and finished to the last man. This is the first in History for annihilating enemies, the bastard Japs in the Province of Lanao.

On August 1942; the Japs again under Col. Tanaka went to Basak area with idea to get the bodies of their deads. They have asked reinforcements from the different units in the Visayas and around Mindanao. Upon arrival at Taraka all the members of the Bolo Bn and other organization, therefore meet them and the enemies were therefore forced to stay at Taraka and mixed with the populace of the place. If they have not again mixed with the populace of Taraka, there will be another story which was expected by all the people of Basak.

Page -3-

From September to December, they have been bombing all the Basak Areas, but the people were never demoralized having measured the braveness of the bastard Japs.

On February, 1943 we heard of an organization of Army Guerilla under General WENDELL W. FERTIG. Being anxious to have a continuous and denounced services with Government and to show our LOYALTY TO THE AMERICAN GOVERNMENT AND THE GOVERNMENT OF OUR MOTHER COUNTRY. On 1st May, 1943 we went to the coast at Linamon and Kausuagan and incorporated ourselves with organization duly organized COL. WENDELL W. FERTIG.
