We are prompted by the sole desire to make known to that Offeed as what all the other members of the Volunteer Guards of the Cebu Area Command had done re-sending of applications for individual recognition as disseminated in a memorandum herewith attach-

For we have no other course to take but to register with that, office the hardships and the ordeals by which the Vg organizations was subjected. Although we are in the mountains and considered far from the light of civilization, to those who mooked us and swore that sail of our efforts excited during the bitterest days of the guerrilla movements in the recent war against Japan would be in vain, all that we could say is God Knows.

We know that there are a million guerrillas claiming for recommition but but most of them were not able to establish when, where and what. But for our case, may we be forgiven for not writing a detailed letter inasmuch as our present situation only permits that we may just be simple and innocent.

May we receive a reply for this heartfelt request and inquisitiveness.
