Dear Mr. Gerilla:

This will acknowledge receipt of your undated letter, in which you request recognition of the roster of Division II Unit II Dagami Area Command.

Special press release from Public Relations Office, AFWESPAC, dated 1 February 1946, stated that no applications for recognition of guerrilla units would be accepted by this headquarters after 15 March 1946. The recent press release from Public Relations Office, PHILRYCOM, further announced the closing date of 15 March 1947, for the submission of individual claims for non-casualty recognition.

It is considered that all concerned had ample opportunity to prepare unit applications for recognition by 15 March 1946. Your request for recognition of the rosters of Division II Unit II Dagami Area Command was received by this headquarters on 24 April 1947. It does not comply with the above closing date and therefore cannot be accepted for consideration.

This decision does not preclude submission of claims for casualty recognition by those individuals who are qualified and feel justified in entering such claims. Upon request from interested individuals, appropriate forms will be forwarded.

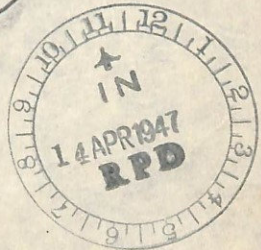
1. Request that the men contained in this roster be processed inasmuch as they have done services to their country. As a proof many have died in the line of duty.
