Dear Mr. Afos,

The "Bolo Organization", purporting to be a guerrilla organization under your nominal control, is not favorably considered for recognition as an element of the Philippine Army.

A set of general requirements for guerrilla recognition, established by General MacArthur during the liberation of the Philippines, has been used as a guide in considering the record of this unit. After careful investigation and full consideration of all available substantiating records, recognition of this guerrilla unit is not deemed to be warranted because of reasons mentioned below:

a. The unit was not maintained satisfactorily in the field in opposition to the enemy.

b. Members of the unit did not devote their entire effort to military activities in the field to the exclusion of normal civilian occupation and family obligations.

c. Many members apparently lived at home, supporting their families by means of farming or other civilian pursuits, and assisted the guerrilla unit on a part time basis only.

I. It is requested that you comply with the provisions of Executive Order No. 68, by the President of the Philippines, dated 26 September 1945, copy attached.

Request of Severo Afos, La Paz, Abra, Luzon, dated 4 March 1946 for recognition of the Bolo Organization consisting of the Bolo Unit, Women's Auxiliary Service and the Men's Auxiliary Service.

1. Disapproved because the unit was not maintained in the field in opposition to the enemy, members did not devote their entire effort to military activities in the field and many members apparently lived at home, etc.

2. These units are definitely of the bolo, homeguard or volunteer type and as such are not considered eligible for recognition.

SUBJECT: Bolo Units, North Luzon

TO : Commanding General, AFWESPAC, APO 707  
(Attn: Guerrilla Affairs Division)

1. In order to clarify the many claims and questions concerning Bolo Units in North Luzon, I wish to enumerate the following:

a. These units were organized throughout North Luzon primarily for the purpose of labor.

b. They were organized on a voluntary bases without any promise for future remuneration.

c. These units rendered excellent service such as: unloading Submarines, carrying supplies and equipment, demolition work, and in some cases actual combat.

d. Many of these units sustained casualties.

2. After 9 January 1945, when USAFIP, NL was authorized to hire civilian laborers, the members of these units were given first priority in order to give them an opportunity to earn.

I have the honor to request that the services rendered by the members of the Bolo Unit, La Paz, Abra, together with the Women's Auxiliary Service and the Men's Auxiliary Service organized by the Guerrillas of the 121st Inf. and the 15th Inf. respectively during their operations in this sector for the liberation of our beloved country, be given due attention to.

These faithful and obedient servants worked side by side with the said 121st Inf. from September 1, 1944 to December 19, 1944 and with the 15th Inf. from December 20, 1944 to April 30, 1945, in combat zones.

Lt. Baltazar Cabuena and the WAS Organization were inducted of Lt. Baltazar Cabuena of Co. "I", 3rd Bn. right on the very beginning of these organizations, but no papers were issued due to the risk and danger of records falling into the hands of the enemies at that time.

Rosters or record of services were kept up to-date and are ready to support any paper if required.

It is further requested that these services be recognized because they did not hesitate to fight against the enemies although they had only their bolos with them. To supply your office with a concrete proof, I have the honor to refer you to Lt. Baltazar Cabuena, Captain Vicente Diana, Captain Eusebio Cabute Jr., Lt. Juan Dumao, etc.

Hoping for the immediate sympathy and attention your good office could render us, we thank you.
