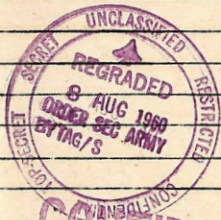

This will acknowledge receipt of your letter, dated 28 November 1946, to the Adjutant General, Army Headquarters, Camp Murphy, Quezon City, in which you request recognition of the Labuan Guerrilla Unit.

Special press release from Public Relations Office, AFWESPAC, dated 1 February 1946, stated that no applications for recognition of guerrilla units would be accepted by this headquarters after 15 March 1946. Your request for recognition of the Labuan Guerrilla Unit was received at this headquarters in your letter dated 28 November 1946 and does not meet the deadline referred to above.

It is generally considered that all concerned have had ample opportunity to prepare applications for recognition. In the opinion of this headquarters, your request for an extension of the time limit mentioned above is not adequately justified and therefore, is not favorably considered.



This will acknowledge receipt of your letter, dated 10 April 1947, in which you request recognition of the Volunteer Guerrillas of Labuan, Zamboanga City.

Special press release from Public Relations Office, AFWESPAC, dated 1 February 1946, stated that no applications for recognition of guerrilla units would be accepted by this headquarters after 15 March 1946. The recent press release from Public Relations Office, PHILRYGOM, further announced the closing date of 15 March 1947 for the submission of individual claims for non-casualty recognition.

It is considered that all concerned had ample opportunity to prepare unit applications for recognition by 15 March 1946. Your request for recognition of the Volunteer Guerrillas of Labuan was received by this headquarters on 16 April 1947. It does not comply with the above closing date and therefore cannot be accepted for consideration.

This decision does not preclude submission of claims for casualty recognition by those individuals who are qualified and feel justified in entering such claims. Upon request from interested individuals, appropriate forms will be forwarded.
