This will acknowledge receipt of your letter, dated 16 July 1947, addressed to Major Robert B. Lapham, requesting information regarding Squadron 224, 226, and 227, Old Broncho Unit, LGAF.

A set of general requirements for guerrilla recognition, established by General MacArthur during the liberation of the Philippines, was used as a guide in considering the requests for recognition of these guerrilla units. Records of the LGAF on file at this headquarters indicate that Squadron 227 of the Old Broncho Unit satisfactorily fulfilled these requirements. Recognition was therefore extended to this unit.

Unit which served in a reserve capacity, such as Squadrons 224 and 226, are unfortunately, not qualified for official recognition. CWC

The services rendered by yours and similar organizations, although failing to attain to the standards required to substantiate official recognition, were indeed of great value, both to organizations which received recognition and to the resistance movement as a whole. The undying gratitude and profound admiration of your fellow countrymen and of all liberty-loving people the world over are extended to you and all those like you who served their country so valiantly.



MEMORANDUM: TO CTO., Squadron #224:

1. REPORTING FOR DUTY:

I wish to explain why I could not report for duty today. Recently, ~~in~~ I acquired TWO HUNDRED FORTY-THREE (243) cavanes of palay. I began to issue these on the 17th and up to this writing, I have not finished issuing them. As you know very well, the families come from different barrios, some about ten (10) kilometers away. For this reason, the issuing is rather slow. Not only that some or most of them perhaps went to the commandeered rice for a share. I still have twelve (12) families who have not as yet drawn their rations. Inasmuch as I may be away for a long time, I decided to finish the issuing before I report for duty. Not only that, I have to fix up my vouchers in order so that there may be no trouble later on. I doubt very much if I can accomplish all of these this afternoon but I will do my best. For this reason, I decided to report tomorrow morning when you come down to Guimba. (I understand you are coming down, so I will be watching for you at Cavite or if I cannot wait for you there, I will go to town to wait thereat).


