

SUBJECT: Recognition of Guerrilla Units

TO : Commanding General, United States Army Forces in the Far East, APO 501.

1. Since the arrival of the AACS Detachment in Manila, approximately 10 February 1945, valuable service has been rendered this organization by Bowley's Combat Unit, a part of the Yay Regiment, Marking's Fil-American Guerrillas. Personnel of this unit have, until recently, kept up a continuous guard around the Quezon City and San Francisco del Monte installations of this organization. In addition, at our request, this unit furnished guards, and occasionally still does, for aircraft arriving on Zablan Airfield and on the old Quezon Strip. During the first sixty (60) days of this organization's activities in the Manila Area, air-evacuation operations were proceeding from both strips and guards were cheerfully furnished at any hour of the day or night to prevent loss through theft or sabotage of any American equipment.

2. Attached hereto as Incl 1 is a letter, 16 April 1945, from Captain Brooke Stoddard, Commanding the Rizal Guerilla Group, which has been attached to the 43rd Division, requesting that this unit be granted recognition in order that the personnel may receive pay and allowances. Attached as Incl 2 is a roster of this unit which has been supplied to us by the Commanding Officer, Captain Bowley.

3. It is possible for this headquarters to certify that service was rendered during period 10 February 1945 to the present date by the unit. No record has been kept of the number of guards employed daily, however, it is estimated that this number has varied from as low as twenty (20) to as high as eighty (80) in one day.

4. It is requested that necessary action be taken to have this unit recognized as a part of the Yay Regiment. Colonel Marking, Commander of this regiment, advises that this is C Company of the 4th Battalion of his unit. Letter from Headquarters Sixth Army, File 370.64-B, 16 May 1945, officially recognizes the Yay Regiment.

5. This headquarters would appreciate early information as to any further action required from us to obtain remuneration for
