



TO : Commending General, United States Army Forces in the Far East, APO 501.

- 1. Since the arrival of the ALGS Detechment in Mentle, Approximately 0 merunary 1635, valuable service has been rendered this organization by Rendey's Combet Unit, a part of the Tay Regient, | Marking's Fill\_American Guerrillan.
