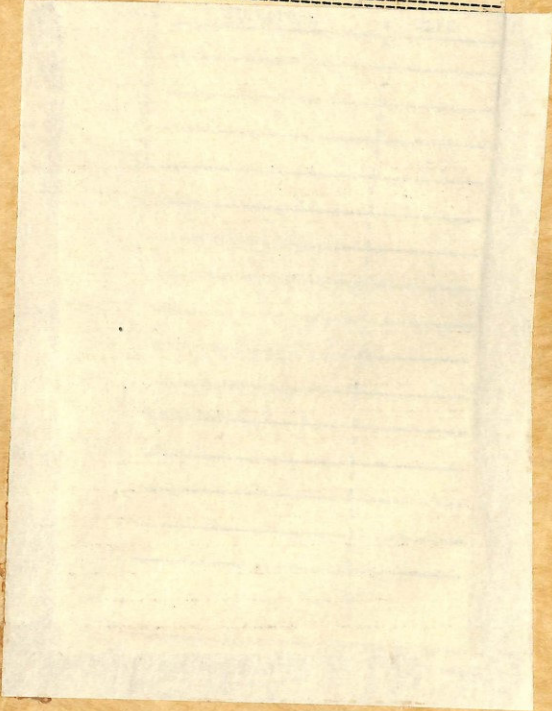

4. The Hq & Hq Co & Cos A, B & C, 2d Bn, 1st Pangasinan Regt, PTMD (as published in par 1c, ltr, GHQ, AFPAC, APO 500, 28 June 1945, subject: "Recognition of Guerrilla Units", AG 370.64) is hereby re-designated Hq & Hq Co & Cos E, F & G, 2d Bn, 1st Pangasinan Regt, PTMD.

5. Under the provisions of Executive Order No. 21, by the President of the Commonwealth of the Philippines, dated 26 October 1944, the status of members of these units is that of officers and enlisted men of the Philippine Army.

6. It is desired that a roster of the personnel of each of these units be forwarded at the earliest practicable date.

7. It is further desired that payment of these units be facilitated by Finance Officers of the Philippine Army, attached to your command.
