Dear Sire

In connection with your letter dated 8 March 1948, giving us it's due comments regarding the status of our guerrilla Unit as being unable to comply and without any submitted records enclosing request for recognition on or prior to the deadline set by the office of the AFWESFAC; this, we claim were the results of our weak judgment and views, and particularly on our having relied on a high degree to Mr. Pablo de la Cruz, to whom we have entrusted to handle this matter with PHILEYCOM, or the former office of the AFWESFAC,

We regret to inform you of our belated desire to request a reconsideration, which we now know as not in conformity with your announced policy in relation to the closing date of accepting request for guerrilla unit recognition. But we still hope and have the impression that the following circumstances, datas, and correct evidences of our Unit's active perticipation in the resistance movement during the Japanese cocupation and up to the liberation of the Philippines would in our conviction be sufficient, in your changing or to further extend the deadline of 15 March 1946; they are

- a. Chronological history of the Organization.
- b. Photo- static copy of authorization to organize
- c. True copies of Communication, vouchers, etc. used during the existence of the Unit.

And upon receipt of your kind consideration, we will furnish you more supporting evidences to show the genuineness of this guerrilla organization.

Trusting that the foregoing datas will warrant your most favorable attention, I beg to remain

Dear Mr. De los Santes:

This will acknowledge receipt of your letter, dated 30 January 1948, requesting information concerning a request for recognition of a Santa Maria Detachment, McKinley Division, Fil-American Irregular Troops.

A thorough search of the files of this headquarters has failed to disclose a request for recognition of a claiment guerrilla unit by this name presented either as an independent unit or as a subordinate unit of a larger command. This headquarters has no record of the rosters and supporting papers which, you state, were to be submitted by Mr. Fable de la Crus of the McKinley Division, FAIT.

It is desired to inform you that a special press release from the Public Relations Office, Headquarters, AFWESFAG, dated 1 February 1946, announced the closing date of 15 March 1946 for the acceptance by this headquarters of unit applications for recognition. Inasmuch as this closing date received wide dissemination throughout the Philippines by press, radio and municipal agencies, it is considered that all concerned had ample opportunity to prepare and submit unit applications prior to the announced closing date.

For your further information, a special press release from the Public Relations Office, PHIRTOCM, dated 8 January 1947, announced the closing date of 15 March 1947 for the submission of individual datase for some annies recognition. A further press release from this headquarters, dated 15 June 1947, announced the closing date of 31 July 1947 for the submission of all types of claims for casualty recognition. requesting information conterming a request for recogni-

In view of the above-mentioned closing dates, no claims of any type for guerrilla recognition can be accepted by this headquarters.
