This will acknowledge receipt of your letter to the Veterans Administration, dated 26 February 1948, requesting recognition of a Volunteer Guard Bolo Battalion of Panolo-on, Kapatagan, Ianao, forwarded to this headquarters for reply.

It is desired to inform you that a special press release from the Public Relations Office, Headquarters, AFNESPAC, dated 1 February 1946, announced the closing date of 15 March 1946 for the acceptance by this headquarters of unit applications for recognition. Inasmuch as this closing date received wide dissemination throughout the Philippines by press, radio and municipal agencies, it is considered that all concerned had ample opportunity to prepare and submit unit applications prior to the announced closing date. Inasmuch as your request for recognition of your unit was made in your letter of 26 February 1948, it does not comply with the closing date of 15 March 1946 and therefore cannot be accepted.

However, to be safe and secure I take the risk of sending it to that Office praying and requesting that it be given favorable attention. Persistent rumors that Volunteer Guards will be paid for their services rendered during the last war prompted me to send in this roster.

Request, please send me a copy of a memorandum circular or any official communication that may serve as an official information for my anxious neighbors and comrades on this matter.

Please advise me of any action taken on this regard. Thanking that office in advance for any attention that it shall give me.
