

The Company "A", Solo Unit, purporting to be a guerrilla organization under your nominal control, is not favorably considered for recognition as an element of the Philippine Army.

A set of general requirements for guerrilla recognition, established by General MacArthur during the liberation of the Philippines, has been used as a guide in considering the record of this unit. After careful investigation and full consideration of all available substantiating records and testimony of witnesses having pertinent knowledge, recognition of this guerrilla unit is not deemed to be warranted because of reasons mentioned below:

- a. The unit was not maintained satisfactorily in the field in opposition to the enemy.
- b. Activities of the unit did not contribute materially to the eventual defeat of the enemy.
- c. Members of the unit did not devote their entire effort to military activities in the field to the exclusion of normal civilian occupation and family obligations.

It is requested that you comply with the provisions of Executive Order No. 68, by the President of the Philippines, dated 26 September 1945, copy attached.

Lt. Col. H. L. Shaftoe:

1. Co "A", apparently an independent Bolo Unit, under command of Leon Cadiante is unfavorably considered for recognition on the basis of its being a bolo unit. It submitted a roster of 48 members.

2. Basis for non recognition:

- a. The unit was a blade type unit with no weapons or ammunition.
- b. The unit was not maintained satisfactorily in the field.
- c. Activities of unit did not contribute to defeat of the enemy.
- d. Members of the unit did not devote entire efforts to military activities in the field to the exclusion of normal civilian pursuits and family obligations.

SUBJECT: Bolo Units, North Luzon

TO : Commanding General, AFWESPAC, APO 707  
(Attn: Guerrilla Affairs Division)

1. In order to clarify the many claims and questions concerning Bolo Units in North Luzon, I wish to enumerate the following:

- a. These units were organized throughout North Luzon primarily for the purpose of labor.
- b. They were organized on a voluntary bases without any promise for future remuneration.
- c. These units rendered excellent service such as: unloading Submarines, cargadoring supplies and equipment, demolition work, and in some cases actual combat.
- d. Many of these units sustained casualties.

2. After 9 January 1945, when USAFIP, NL was authorized to hire civilian laborers, the members of these units were given first priority in order to give them an opportunity to earn.


