1. On 21 April 1946, Opt 5. O. Buchenna and lat Lt Jaine H. Mannen turreled to the provinces of Penganga and Ratean to contact four subordinate unit commanders of the EGLSA. The mission was to deliver letters to the individuals concerned informing than that discrependies existed between approved strengths satherized for their previous contact of the EGLSA. - All the individuals were contacted with the exception of Anderes Migeno whose whereabouts is unknown although runor has it that he is in the Visayan Islands and cannot return home for reasons of personal safety.
- 3. It is significant that all three persons contected (Oristobel, Formendes and Remos) exhibited no sumprise when apprised of the initial strengths suthorized their units and all three (all interviewed separately) volunteered the information that they did not subset the rooters of their units for recognition purposes, but that "somebody" higher up took ears of that little item. Formendes either the results of the ground product of the transport of the "somebody" higher up the content of the "grounds" guerrillas. None of the "three displayed overt reluctance to screen their rooters to the proper figures.


