Dear Mr. Valencia:

The Commanding General has directed that you be informed that the "Squadron 54, ECLGA," purporting to be a guerrilla organization under your nominal control, is not favorably considered for recognition as an element of the Philippine Army.

A set of general requirements for guerrilla recognition, established by General MacArthur during the liberation of the Philippines, has been used as a guide in considering the record of this unit. After careful investigation and full consideration of all substantiating records and testimony of witnesses having pertinent knowledge, recognition of this guerrilla unit is not deemed to be warranted because of reason mentioned below:

a. Record of service was not substantiated by sufficient acceptable evidence.

It is considered that the previous recognition of approximately 1791 officers and men from the Northwest Pampanga Military District, ECLGA who were recognized by the Commanding General, AFWESPAC for their aid during the liberation of the Philippines constitutes adequate and just acknowledgement of military service.

It is requested that you comply with the provisions of Executive Order No. 68, by the President of the Philippines, dated 26 September 1945, copy attached.

Thru : COMMANDING GENERAL, 86TH INF DIV APO 450
Attention: Guerrilla Affairs Officer.

1. Request that recognition be given this specific Guerrilla Organization for the following reasons and papers related hereto are furnished and inclosed herewith for the information and guidance of that Headquarters:

a. During the Japanese occupation my unit have actively served in the resistance movement, in the capacity of espionage work, fighting against (Sgt.) japs soldiers everytime my men have the chance of out numbering japs patrol and have lost a few casualties as can be noted on the attached roster of unit; and always procured supplies for the Americans who have guided the guerrillas in the methods of fighting, which I believed have contributed in the success of the movement.

b. My unit have assisted the Liberation forces during the operation at as early as Jan 28, 1945, guiding the advance patrol from Angelea bound to Porac, and was later attached permanently to the 69TH F. S. up to June 1, 1945, and after our release from attachment we became abandoned and not recognized, having received no instructions from engaging U S ARMY unit that could have insured the status of my men.

c. Because of the ignorance of procedure to follow my unit was as it appear now being deprived of the privileges of the bonafide and deserving guerrillas, who are likewise entitled as those who are now enjoying the benefits therein; they (my men) also ^{have} given themselves freely for the cause, disregarding their own personal interest.

2. In view of the foregoing it is believed that due recognition accorded subject personnel is but just and fair considering their services rendered prior and during the operation of the liberation forces.






