Receipt is acknowledged of your undated letter, Subject: "Request for Recognition of 'D' Company".

Special press release from Public Relations Office, AFWESPAC, dated 1 February 1946, stated that no applications for recognition of guerrilla units would be accepted by this headquarters after 15 March 1946. This press release received wide circulation in the newspapers and was broadcast over local radio stations.

Your request for recognition of ("D" Company), East Central Luzon Guerrilla Forces of Luzon, (Florida District), (San Pedro) unit was received at this headquarters 2 December 1946 in an envelope postmarked 27 November 1946 and does not meet the deadline referred to above.

It is considered generally that all concerned have had ample opportunity to prepare applications for recognition. In the opinion of this headquarters, your request for an extension of the time limit mentioned above is not adequately justified and is not, therefore, favorably considered.
