Dear Mr. Peregrino:

The Commandi g General has directed that you be informed that the supplementary rosters of Company A, Squadron C, Magsaysay's Forces, ZMD, and Company(D) Cabangan Sector, Squadron C, Magsaysay's Forces, ZMD, purpurting to be a guarrilla organization under your nominal control, are not favorably considered for recognition as elements of the Fhilippine Army.

A set of general requirements for guarrilla recognition, established by General learthur during the liberation of the Fail applies, her been used as a guide in considering the record of these units. After careful investigation and full consideration of all available subtantiating records and testimony of witnesses having pertinent knowledge, recognition of these guarrilla units is not deemed to be warranted because of reasons mentioned below:

a. Adoquate records were not maintained (manes, ranks, dates of enlistment or joining, dates of provotions, and necessary related information).

b. Record of service was not substantiated by sufficient acceptable evidence.

It is considered that the previous recognition of approximately 254 officers and men fro Headquarters and Headquarters Company, Companies 4, 2, and 6, Cabancan Sector, Magneyay's Forces, All Anich were recognized by the Commanding General, Alleria for their aid during the liberation of the Philippines constitutes adequate and just acknowledgement of military service.

Report on "Gabansan Sector, Squadron "C", Zambeles Military District," (ZMD)

In accordance with verbal instructions from Chief of Section, Guerrilla Affairs, G-3, AFWESFAC, Lieutenant Morris S. Flory, on 10 July 1946, proceeded to Cabangan, Zambales to contact the "Gabangan Sector, Equadron "C", ZMD, in order to determing whether or not this organization should be recognized by the United States Army. The following report is a summary of the investigation and basis for the recommendation.

ALLEGED HISTORY

In August 1942 the Cabangan Sector was formed with an original strength of 80 officers and EM as a part of the Mg-loma and San Felipe Sectors. Late in August 1942, by order of Col. Thorps and Capt. McGuire the Cabangan Sector was separated and became an independent sector under the Western Luson Guer-rilla Forces with Lt. Herminiano Peregrino of the 88th FA. USA-FFE, as GO, who was given the rank of Captain, and Lt. Eulogio N. Peregrino as Adjutant and Executive Officer. McGuire alloted the Cabangan sector an initial strength of 450 men of which 42 were enlisted as of September 30, 1942. Headquarters was first set up in Mabanglit near the Zambales Mts., but as the Japs advanced, it was moved from time to time.

In the early part of 1943, because of Jap reprisals against civilians for guerrilla activity, the GO gave anders to concentrate on Jap collaborators and spies which constituted their work up until the time of the American Landings on Luzon.

Capt. H. Peregrine was captured by the Japs on 19 April 1943 and his brother, the Executive Officer of the Sector, took control of the unit. However, after the capture of Gapt. H. Peregrine, many of the members surrendered to the Japs, while some remained hidden in the mountains afraid of Jap reprisals if they surrendered. At the time of the capture of H. Peregrine, E. Peregrine was given command, in absence, for he was then in Mueva Ecija Ets with Gol. Lapham's outfit; Without a leader the sector became inactive.

In June 1944, a U. S. Army pilot, Eddie Higginbottem, arrived in the Zambales Mts and, after his recovery on 1 October 1944, helped reorganise the Cabangan Sector with a total strength of 515 officers and men. This time the unit was attached to Gol. Merrill's Forces, later to become known as "Magsaysay's

Guerrilla Forces."

Capt. E. Peregrino was the CO until his capture by the Japs on 19 October 1944, at which time Capt. Faustino Capati of the "General Service Troops, Cabangan Sector," became GO of Squadron "C" and Capt. Estanishao Roquine assumed command of the Cabangan Sector.

Upon the release of Capt. E. Peregrino on 5 February 1945 by American forces, he returned to reorganize the disrupted Cabangan Sector, becoming CO of the Sector with Capt, Bernardo C. Mora of "General Service Troops" as CO of Squadron "C". This squadron comprised the Gabangan, Maless, Santa Fe, San Marciso and San Antonio areas as units of the ZMD. On 18 May 1945 Capt. E. Peregrino again became Squadron "C" Commander with Capt. Mora and Capt. Feliciano B. Fontelera as Sector Commanders.

The Cabangan Sector, consisting of one battalion, was composed of 5 companies, Eq & Eq Co, Co's A, B, C and D with a peak strength in 1945 of approximately 500 officers and mem.

The primary activity of this wait was against spies and collaborators until the arrival of American forces at which time they were engaged in guard, scout, patrolling and mopping un operations.

354 men of Hq & Hq Go, Go's A, B and C have previously been recognized from this Sector.

FINDINGS

The following named persons are those interviewed by the Contact Team and their statements are the basis for the findings:

- 1. Capt. Eulogio N. Peregrino CO, Squadron "C" Antonio Angeles - Judge of Cabangan, home in Sta Cruz 2.
- Magdaleno Solomon Sgt, Co A, Cabangan Sector Alineo - Mayor of Cabangan, former Ex Off, Go D
- A. Gusman MPC, Iba, former resident of Cabangan
- Lt Gol Leidy Ex Off, 14th AA Command Maj. Magsaysay GO, ZND
- Lt. Federico Labrador Adjutant, Squadron "C" Pedro Arabego Co E, Squadron "C"
- 7. Four Arabego Go S, Squadrom Go Arturo Gabling S/Sgt, Go D, Gabangan Sector 11. Aurora Barretto S/Sgt, Go D, Gabangan Sector 12. Florencio Alinea 2nd Lt, Go D, Gabangan Sector 13. Maximo Ebalo 1st Lt, Go A, Squadrom Go H. Amastacio Borja, S/Sgt, Go A, Squadrom Go Aurora Garcio Sgt, Go A, Squadrom Go Aurora Garcio Sgt, Go A, Squadrom Go

Open investigation it was found that this unit up to the time of American occupation of this territory was frequently out of control due to the capture of the leaders at different times. Go A, Squadron "C", Magsaysay's Forces, pending recognition, is claimed to be different from Go A, Gabangan Sector that has already been recognized. The letter of attachment, signed by Albert F. Trude, 1st Lt, 152nd Inf, the only letter of attachment, refers to the recognized Go A, Gabangan Sector. The men on the rester are mostly from other sectors. Their claimed work was as guides to American units, working all the way from Gabangan to San Antonio. There are, however, no papers to prove these claims.

Ga D, now claiming recognition, claims to have worked with the recognized Hq & Hq Co, Co's A, B and G, but were under Capati and not under Peregrino who at the time was a prisoner of the Japs. Cartification states that 5 officers and 63 Em supported the 152nd Inf but it specifies only Cabangan Sector, giving no particular company while there are 5 companies that claim or have already been recognized. The Executive Officer of Go D, Alinea, now Mayor of Cabangan knew little about the activities of Co D, giving as an excuse that policies changed and referred me to Peregrino. There is no proof that Co D existed as a military unit. It is concluded that the members of this organization prior to the American occupation did not have full time status as a guerrilla, and that the members of the unit worthy of recognition have been recognized with Hq & Hq Co, Go's A, B and C of the Cabangan Sector, Squadron "C", Magsaysay's Guerrilla Porces, ZMD.

POLITICAL ASPECTS

This unit does not appear to have any political affiliations or aspirations.

RECOMMENDATIONS

After careful consideration of the statements made by the present members and an analysis of the documents presented, it is recommended that with the exception of those members previously recognized, the Gabangan Sector, Squadron "G", Magsaysay's Forces, ZhD, be not favorably considered for recognition.

Being Company Commander of Co. D. Cabangan Sector, under Squadron "C", within the ZMD, Magsaysay's Forces USAFFE, I am committed to my men for any development regarding recognation of my unit. In view to this, I hereby kindly request information effecting our cases, and whatever development made, we highly regards it, the greatest of favor it we are so notified.

Capt. Eulogic N. Peregrino, C. O. Squadron "C", ZMD, Magasyasy's Forces USAFFE PA, who was just recently demobilized, when asked about our recognation, says - he is not in a position to commit, only he says - he had long submitted our Roster for recognation together with necessary certification of attachment from American Unit we supported operation during the Liberation Campaign, so he further says, it would be adviceable to find it out.

After the official surrender of Japan, for lack of accommodations, equipments, quarters and rations we were left as home guards. Our outfilt, or rather say, those in the Initial Rosters were moved and incamped at Sam Marcelino Airstrip which later, they were transferred again at Camp Porac, Pempanga, For failure to receive order to report, most of us left to find means of livelihood, and as for myself, when offered the position of Mayorship of this town, I accepted appointment which position I am at present holding.
