

The following guerrilla units were organized and attached to Anti-Tank Company, 1st Infantry effective as of 26 April 1945; Squadron "C" which comprises the Squadron "C" Headquarters, Cabangan, the Cabangan Sector (Company "A"), The Maloma Sector (Company "B"), the San Felipe Sector (Company "C"), the San Narciso sector (Company "D"), and the San Antonio sector (Company "E").

2. The above named units were employed to support operations of the 1st Infantry Regiment in Zambales Province from 26 April to 28 June 1945 inclusive. On 29 June 1945, Squadron "C" was relieved from attachment to Anti-Tank Company, 1st Infantry, and was attached to 3rd Battalion, 152nd Infantry, 36th Division.
