

The recomendation given to the 1st platoon Company D, thru long and faithful service by 1st. Lt. FROME, then commanding officer of the 17th Platoon, 595 Air Warning Battalion, was taken by Capt. Andres Padrigo and Capt. Benedicto Evangelista of Squadron C, Magsaysay's Forces with the understanding that the said Captains should worked first for the recognition of this platoon, prior to any other company of their organization. It was by means of that recommendation, which they used so cleverly, and unscrupulously for the recognition of other companies. striking out the names of the members of this plateon from their resters. Would such anomallies and deception and treachery go without investigation and examination leaving the rightful owner without recognition and without reward? Would Capt. Padrigo and Capt. Evangelista with other officials go without being investigated in using such certification for their own material greed and personal and financial benefits leaving this platoon who had earnestly, faithfully, and deligently earned such recomendation, groping in the dark?

It is true that Cept. Padrigo and Capt. Evangelista with the members of other companies, worked in Makinaya, Subic, Zembales, but they were not labor battalion munder the name of the guarillas.
