



2. The above units were in active support of operations of the 38th Division from 29 January 1945 to 15 March 1945. Attached hereto a roster of the Magbuña Sector duly certified by Brig. Gen. William Spence, Commanding General, 38th Division Artillery. Also a letter from Brig. Gen. Spence addressed to Lt. Felix Abaya, C.O., Magbuña Sector.

3. This unit was used in capturing the Airstrip at San Marcelino, Zambales from the Japs four days before D-Day in Zambales under my personal command (XI Corps and its elements landed in Zambales on 29 January 1945). After the airstrip was captured the whole battalion was used in removing and exploding the land mines planted by Japs on the runway under the supervision of Lt. Wayne Dunker and Ensign Rickards who earlier were rescued and taken care of by the men of the Magbuña Sector. The job of clearing the airstrip of mines was finished in one day so that the Fifth Air Force which landed at Zambales with the XI Corps was able to use the airstrip at once and was enabled to support land operations of the 38th Division at Zigzag Pass. This is only one of the many activities this unit


