1. Paragraph 1, letter, Headquarters, United States Army Forces, Pacific, file AG 370.64, subject: Recognition of Guerrilla Units, dated 22 October 1945 is amended to read as follows:

"The following guerrilla units are recognized by the Commander-in-Chief, United States Army Forces, Pacific, as having been authorized elements of this command from 4 February 1945 to 15 March 1945:

3 - <i>Co</i> Hq & Hq Company, San Marcelino Sector	107
4 - <i>Co</i> Company "A", San Marcelino Sector	193
5 - <i>Co</i> Company "B", San Marcelino Sector	193
6 - <i>Co</i> Company "C", San Marcelino Sector	190
7 - <i>Co</i> MP Company, San Marcelino Sector	135

2. The following paragraph is added to above mentioned letter:

"4. Under the provisions of Executive Order No. 68, by the President of the Commonwealth of the Philippines, dated 26 September 1945, all officers and enlisted men of this unit, other than those who are members of the regular army or the Reserve force of the Philippine Army, will be considered as having been discharged from the Philippine Army as of 16 March 1945."


