My dear Colonel Lillard:

This is in connection with the case of the eleven officers and men of the Subic Sector which I took up with you the last time I went to your office.

As you will remember, I called your attention to the fact that in the revision of the recognition of the 1200 officers and men of the different sectors under my command, eleven officers and men of the Subic Sector have been inadvertently omitted in said revision inspite of the fact that their names were also carried in the rosters submitted duly certified by Major Donald H. McGovern of the 343rd Infantry, 86th Division, to whom units of the Zambales Military District were then attached. You then stated that the reason why these men in question were not included in the revised roster was the fact that your office thought that these officers and men were already recognized as regular guerrillas in the roster of the Subic Sector which consisted of 11 or 12 men. I contended, in this connection, that the 12 men carried in the originally recognized roster of the Subic Sector are different from the eleven men in question and you promised me that in that case you would act to effect revision of their recognition.

I have checked this matter with records in the Philippine Army and my contention has been confirmed by said records that the eleven men of Subic Sector whom I have asked your good office to include in the revised rosters of the Zambales Military District, are entirely different from the 12 men (Subic Sector) originally recognized as regular guerrillas. I am, therefore, enclosing herewith the names of the twelve regular guerrillas whose recognition came down in June, 1945, as per Supplement No. 5, GHQ, AFPAC, and also the names of the eleven officers and men in question, for your information and necessary action.
