2. I repeatedly have called A.F.S. pointing out the continued unsatisfactory situation, but A.F.S. has advised me that they are unable to receive replies to their letters directed to A.F.C. 928.

3. In the meantime, the unexpected attending of the date for one of our missions, for which Groups was trained as leader, has created the need for emergency action. It is for this reason that the above request for Orders is made.

4. Reference is made to the accompanying Check Sheet concerning the issuing of Secret Letter Orders on Lieut. Groups and three enlisted men.

1. In order to enable the execution of Special Orders to permit him to participate in a special AIB mission, it is requested that immediate orders be effected arranging the transfer of -

2nd Lieut. DOMINGO, GREGO, DO-888253.

from Ship and Gun Crew Command to WASSON for duty with AIB.

2. I have conferred in the Adjutant General's office concerning a serious irregularity in this officer's record, and on making the above request after talking to Major Cisneros, who will take up the matter with Colonel Fitch. For the information of 8-2 and the Adjutant General, the following facts are presented:

- a. Lieut. Gropo came to my office on 21 January, stating that he was on sick leave from his station at APO 508 (Milne Bay), where he had been serving in the A.T.S. pool. He appeared to be likely material for Philippine Section of AIB and, since he was on leave, I asked him if he would care to undergo some training, it being my plan to ask for his transfer if observation sustained my opinion that he was a good prospect. He showed sufficient promise to justify such action. Lieut. Gropo told me that, owing to his illness, his Commanding Officer at Milne Bay had informed him that he should arrange to stay in Brisbane and that his transfer to A.T.S., Brisbane would be forthcoming.
- b. On this basis, I called Colonel Gria and asked him if he would arrange for Gropo's transfer to Brisbane and that in a short time I would be prepared to, in turn, transfer him for duty with AIB. Colonel Gria then was called north.
- c. Near the expiration date of Gropo's sick leave, which was early in February, I called A.T.S., Brisbane to try to bring these leave ends, but found that Colonel Gria had gone, that the Adjutant was ill and that Major Cisneros also had been sent north. To protect Gropo, I took it upon myself to send a message to his C.O. at Milne Bay, stating that we were trying to effect the transfer but that a delay had been encountered. In the meantime, Gropo still being in a weakened condition, I suggested that he could go on living at the AIB School until A.T.S. officials were prepared to effect the proper transfer.
- d. When the A.T.S. Adjutant returned from the hospital, I called him and pointed out the unsatisfactory state of Gropo's status. He said he would

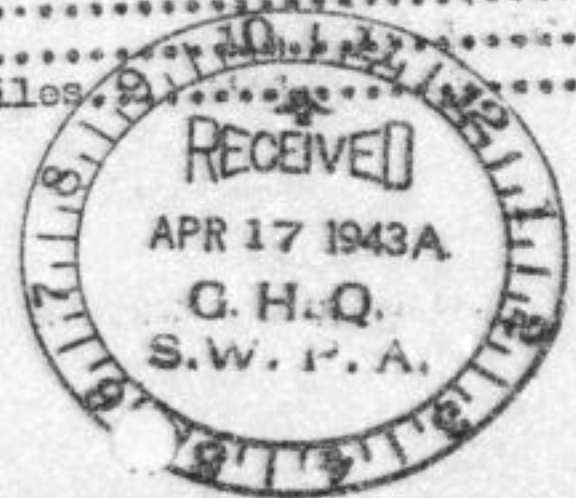
