By **Dear Sir:**

Thank you for your letter of the 29th just received.

I was sorry that I did not see you prior to your departure as I wanted to tell you that my purpose in sending you back to the Battalion was to give strength to the instructional staff upon the early projected relief, for more active service, of officers who have earned the opportunity through diligence, if less desirable, your service.

While your loss of weight and general physical decline had the effect to prompt me to speed up your transfer, it did not by any means control my decision as I felt sure that by rest and medical care you could soon have restored your health without departure from this area.

I want you to know that these things occur to the best of us as is evidenced by Commander Parsons' breakdown under severe nervous strain, so do not think for one moment that your return to the Battalion was in any respect a reflection upon you personally, but was rather to strengthen my position at a time when other officers were about to be separated from the Battalion and at the same time afford the opportunity for a speedy restoration of your health under more favorable circumstances.

Your service as a consultant with me in the development of our vital signal communications had been splendid. You have always sustained a high degree of initiative and enthusiastic attention to your duties. You may therefore feel a justifiable sense of satisfaction that your past service has been most honorable and valuable. There is no doubt in my mind that it will continue to be so in future.
