Somewhere in The Philippines  
Jan. 12, 1944

Dear Col. Ind:

I am taking the liberty of writing  
this short personal letter of mine to you  
Sir, and judging from the date line, its  
the anniversary of our landing here in  
the Philippines. A year had gone, through  
lots of hardships, privations and sickness.

I had been suffering from malaria  
for the last six months, and lately there's  
that complication of my kidneys.

When Maj. Villamor left, he promised  
to take my case to you, if it is possible  
for me to go back to Australia for a

short rest. Nothing had been heard from him, and indications are - he probably had forgotten about me.

I neednt tell you Sir, how much I really wanted to do my bit, and since our conversation in Port Moresby, my feelings and desire to do something for the common cause is still with me, and will go on forever as long as I can.

Since my first contact with you on February 27<sup>th</sup> 1943 up to the present, am continuously on the job without a single day of rest. Theres that moving up through jungles and mountain fastnesses





to evade capture, and even with malaria we had to go on, and since nobody takes my place, I can say with frankness that I have always done my bit.

Major Cruz, who is bringing this letter to you, sir, personally knew my case and he can vouch for this statement regarding my health.



I beg of you sir, if you can see your way clear for my recall for this much needed rest and hospitalization, and as soon as I am able, I will gladly return to my post, or to any assignment, the Colonel may care to
