SUBJECT: ASSUMPTION OF RANKS AND NAMES BY ALL MEMBERS
OF THE PARTY UNDER LT. ENRIQUE TORRES JR.

TO : GHQ, SWPA

1. Be it brought to the knowledge of this Headquarters that 1st. Lt. Enrique Torres Jr. and the undersigned have assumed the ranks and names of Maj. Jaime Flor and Capt. Jose B. Miel respectively upon arrival to their destination. All the enlisted men in this party, likewise have assumed the ranks of 2nd. Lt., with their respective assumed names.

2. Reasons: Civilians pay more attention to the advices of an officer than to those of a mere enlisted man. Guerilla men respond quicker to the orders of officers than to those of non-commissioned officers. This action had been and will be of great help to the hazardous job of accomplishing our mission. The assumption of names is merely for security reasons.
