SUBJECT: Military Service.

TO : Col. Courtney Whitney.

Reported for active duty under the Thomson Act at Fort Bliss, Texas on 5 July 1939. Was assigned to the 8th Cavalry with which I remained for a year and a half.

20 December 1940 left Fort Bliss on terminal leave with orders for the Philippine Department. Arrived in Manila 20 February 1941 where I was assigned to the 26th Cavalry (P.S.) On 25 February 1941 I was promoted to 1st Lt. Remained with the 26th Cavalry until cut off from it in combat 22 December 1941.

22 February 1942 I reported for duty in Pansy to the C.G. of the 61st P.A. Division. By orders from G.H.Q., Corregidor I was attached to the division and given the job of S-3 of the 63rd regiment. 1 April 1942 I was promoted to Captain. 25 May 1942 I surrendered with the division to the Japs.

1 June 1942 escaped from the Japs. 15 November 1942 started working with the guerrillas with whom I worked until 22 August 1943 - the date I left for Australia. Arrived Australia 5 January 1944.
