HENDRICKSON SERIOUSLY INJURED AND MUST BE EVACUATED IMMEDIATELY. WE HAVE TRIED TWICE TO RESCUE HIM BUT WEATHER ENROUTE TURNED PLANES BACK. HE IS ON THE SOUTH SIDE OF DIBUT BAY 15 DEGREES 40 MINUTES NORTH, 121 DEGREES 35 MINUTES EAST AND WILL DISPLAY AIRCRAFT PANEL. PLANE MUST BE A FLYING BOAT. AIR FORCE BELIEVE MISSION COULD BE FLOWN SUCCESSFULLY AT YOUR END. ADVISE.

EXTENSIVE SEARCH OF FILES REVEALS THAT FOLLOWING MESSAGE IS THE ONLY ONE AVAILABLE HERE. CERTAIN MATTERS IN OUR FILES WERE PROBABLY REMOVED WHEN SERGEANT STODDARD WENT THROUGH THE FILES PRIOR TO YOUR DEPARTURE TO LUZON. THERE IS NO INDICATION THAT MESSAGE WAS ANSWERED. "MATTERS REFERRED TO IN YOUR 613 REQUIRE FOLLOWING ACTION: FORWARD PRESIDENT QUEZON THROUGH THIS HEADQUARTERS RECOMMENDATION FOR APPOINTMENT OF GOVERNOR FOR PROVINCE OF PALAWAN TOGETHER WITH EXPLANATION OF STATUS OF REGULARLY APPOINTED GOVERNOR; ONCE GOVERNOR IS APPOINTED BY PRESIDENT QUEZON HAVE HIM SUBMIT HIS RECOMMENDATIONS LATER FOR APPOINTMENT OF JUDGE COURT OF FIRST INSTANCE AS THERE IS NO STATUTORY AUTHORITY FOR DELEGATION OF THAT POWER, HAVE HIM REQUEST AUTHORITY FOR THE PRINTING OF THE CURRENCY REQUIRED WITH AN EXPLANATION OF THE PURPOSES THEREFORE, GIVING PRESIDENT QUEZON THE NAMES OF THE EMERGENCY CURRENCY COMMITTEE OR IF NONE EXISTS HAVE HIM RECOMMEND THREE RELIABLE PUBLIC OFFICIALS TO CONSTITUTE SUCH A COMMITTEE. IN VIEW OF YOUR EXPLANATION OF THE SITUATION THE MILITARY FORCES OF PALAWAN ARE FOR THE TIME BEING ATTACHED TO YOUR COMMAND. ABORDOS
