- 3. Major ABCEDE for "face" has held the guerilla grade of Lieut. Colonel since his assumption of command of the 7th Military District. He still, however, holds the grade of Major in the Philippine Army. He has done a splendid job in the exercise of his command. The intelligence he has sent in is detailed and reliable and his organization for the reception of supplies is superior to that of any other area. In such activity submarine commanders have given him highest commendation.
