New York Times (29 August) devotes four column inches to a special dispatch datelined Seoul, 28 August, which states: "Openly sponsored by the South Korea Communist Party and closely paralleling that in the Soviet controlled North Korea zone, an anti-American propaganda campaign is reaching new heights of falsehood and hysteria.

Recent charges are that United States troops bayoneted laborers during the Communist disorders on August 15; that a Korean policeman received a medal for shooting down an innocent worker in cold blood; that the 17 counterfeiters on trial are innocent patriots; that the Americans are worse than the Japanese, and that the Americans are desecrating the historic Palace Grounds.

The proposed extension of \$21,000,000 credit to Korea by the United States is called by the Communists a bold effort to colonize and enslave Korea.

While this unceasing propaganda drive against the United States continues here, Soviet controlled newspapers and radio station in the Soviet zone capital at Keijo are also hammering away at the United States policy in general and the occupation in Korea in particular."

No other items on Korea noted in today's press.

Summary of articles carried in press on alleged irregularities in China follows:

Washington Post same day has Shanghai UP August 25 story on page three: Liquidation sales in China under probe millions involved. Announcing probe and reporting suggestions that if investigation is not completed soon to satisfaction of American interests there which have complained, Mead Committee or Department of Justice may be asked to act. Probe asked after arrival of Moody. Described as also in Shanghai and interested in probe are McCabe and Vogelback. McKenna said to have resigned in protest over disposal procedures. Same complaint listed as in Times story, plus revocation of signed contracts with an American firm for material later sold to China for smaller sum (may be Steel Sheet deal), and delivery to Chinese Government of ships and other equipment without contract and before agreement was reached on price. Same story, briefer, carried in PM, Washington Star, and Daily Worker. Philadelphia Inquirer, PM and Chicago Tribune same day had China stories reporting charges by Chinese Communists that China Government making secret deal with US for Pacific surplus war supplies including arms. Said Communists would take complaint to General Marshall.

Washington Daily News, headlines: US sells B-25's to Chiang as Reds plan protest to US, with bulletin datelined August 26th, UP, stating that ten B-25 Bombers in operable

condition were turned over to CATC by FLC, apparently in direct violation of Federal Regulations regarding sale of combat equipment without authorization of State Department. Then followed same story as in Tribune, adding that Communists would appeal to UN, if deal between, "Howard Peterson and Premier Soong were not stopped".

New York Times, 26th August carried long story on page 2, datelined Shanghai 24 August, sales of surplus to China examined, irregularities are charged in disposal of goods at prices that are low: Announcing launching of investigation into alleged irregularities in conduct of affairs of FLC in China, as revealed in statement released there by McCabe. An allegation concerns deal wherein Chinese Government Agencies obtained better than normal terms to detriment of American Business Men in China, that established priorities have been disregarded and that opportunities for bulk sales have been passed up in favor of deals in which Chinese buyers have been permitted to "Pick and choose". Another complaint is that CATC has been able to buy 150 Transport Planes at low figure because planes were classified as salvage whereas they were in good condition. Another complaint involved sales of steel sheeting to Chinese Government Agency for less than Texas Company's China Branch offered. Probe is said to proceed simultaneously with final negotiations between FLC and Chinese Government for bulk disposal of surplus in Orient with Arms and Ammunition not included in deal.

Washington Delegation, said also to be investigating China's ability to use all supplies they seek. Communists and Democratic League reported voicing protest over pending

deal. China said to be only potential purchaser, with alternative abandonment of surplus at bases.

August 27th Times has lengthy Shanghai story Chinese Reds plan "Appeal to world" with additional sections, no Arms in surplus deal, and ten US Bombers in deal. Surplus is called big issue with Communists because they feel it lessens their hope of diminishing American aid to Chiang. Although war equipment has been eliminated from surplus stocks, impression in Shanghai is that negotiations come at a bad time. Neutral observers find Communists excessively touchy on American aid to Chiang while Right Wing elements in Nanking on busy lookout to see how far US will go to support Chiang.

Bombers said to be part of lot of 150 planes turned over to CATC, including also 90 C-46's, a number of C-47 and 2 C-87, described as stripped down Liberator Bombers. Delivery of bombers said to have been made known when CATC asked Chinese Communications Ministry for authority to turn them over to Chinese Air Force. New York Herald Tribune and Phila Inquirer carried same story minus fact that no Arms included in surplus deal. No statement issued press other than one sent to US for release by McCabe on August 26th.

In response to question from reporters about reported sale of B-25's to China, Acheson at Tuesday Press Conference said "I could comment on it. I do not think that the statement as you expressed it is correct, although I do not want to be categorical about this. We have asked Mr McCabe to make a complete investigation of the whole matter. As we understand it, there are some B-25's and B-24 planes which have been de-

militarized and as to which a contract has been entered into for sale to the Chinese Government. It was our understanding and our instructions that these planes were not to be transferred until the situation was clarified or changed in some respects in China. We do not think they have been or are going to be transferred, but we are still without complete details and have asked for a full investigation".

Press being told "No further information available here" and that they must await results of investigation in Shanghai.

Please keep us advised.

Today's press carries both UP and AP dispatches datelined Seoul 26 August, reporting an exchange of letters between General Hodge and Soviet General Chistiakov concerning reopening negotiations to set up a provisional Democratic Government in Korea. Both Hodge and Chistiakov expressed willingness to reconvene the Commission which broke up last May, but they still disagree on the same problem, that of consulting Korean Democratic parties and social organizations, according to the dispatches. AP dispatch states that in making the letters public, General Hodge "Renewed his long standing invitation to the Russians to return to Seoul to reopen negotiations," while UP quotes an August six letter from Chistiakov as claiming the Commission broke up "On the initiative and suggestion" of the American representatives, and that the Russians want an "Exact fulfillment" of the Moscow decision; UP quotes Hodge to effect that he objected to the "Unilateral" interpretation of the Moscow decision generally and of the word "Democratic" particularly.

Richard J H Johnston in a special dispatch to New York Times (27 August), datelined Seoul 26 August, which runs to a full column, reports the exchange of letters and states the possibility of resumption of negotiations "Appeared most remote." Johnston reports that by reiterating their previous stands regarding interpretation of the December Moscow decision of Korea, each Commander made it clear neither intended to deviate from the course already taken, yet each expressed eagerness to resume negotiations

Subject: Consolidation and Extension of Officer Separation Criteria. Effective 1 September 1946 the following will govern demobilization of officer personnel of the Army.

I. Officers other than Medical Department officers.

1. Except as listed in paragraphs two and three immediately following, non-volunteer officers are eligible for separation upon completion of 24 months service, and will be separated from the Army by the last day of the month in which the 24 months of service is completed.

2. Scarce category officers whose MOSs appear in War Department Circular 321 of 1945 as amended by War Department Circular 48 of 1946, except civil affairs or military government officers, may be retained in the service until replaced, provided that are utilized in their specialty, but in no case longer than six months beyond the date on which they would be separated under instruction in paragraph one above.

3. Officers whose MOS denotes linguistic ability, and who are being utilized in such MOS, will be separated not later than upon completion of 42 months of service. Officer linguists not being utilized full time in their language specialty will be separated in accordance with provisions of paragraph one above.

4. Above instructions are applicable to officers of the WACs.

II. Medical Department officers.

1. Except as indicated in paragraphs two and three immediately following, non-volunteer Medical Department officers are eligible for separation upon completion of service indicated:

A. Medical Corps officers--- 24 months service.

B. Dental Corps officers---30 months service.

C. Veterinary Corps, Sanitary Corps and Medical Administrative Corps---36 months service.

D. Medical Department dietitians and physical therapists---24 months service.

E. Army Nurses Corps---14 months service.

2. Medical Corps officers with primary or secondary classifications A, B, or C in the following MOSs, and who are assigned to duties utilizing their specialty, are eligible for separation upon completion of 36 months service: 3101, 3105, 3106, 3107, 3112, 3125, 3126, 3130, 3139, 3150, 3152, 3153, 3180, 3306, 3325. Release of such specialists however is subject to the right of the Surgeon General to retain by individual selection a relatively few critically needed specialists where this is essential to the proper care of patients.

3. Eligibility for separation of Medical Corps, Dental Corps, or Veterinary Corps officers who are graduates of Army Specialized Training Program is as follows:

A. Medical Corps---upon completion of 24 months active commissioned service

B. Dental Corps---upon completion of 30 months active commissioned service.

C. Veterinary Corps---upon completion of 36 months active commissioned service.

4. All Medical Department officer upon becoming eligible for relief from active duty under this policy will be separated within 60 days from date of eligibility.

5. All Medical Department officers surplus to requirements of Major Commands or returned to ZI from overseas who are within 60 days of eligibility for release will be separated under provisions of Section 2, War Department Circular 290, 1945.

III. General provisions.

1. Computation of length of service will include total honorable active commissioned and enlisted service, continuous or interrupted, since 14 September 1940. Time lost under Article of War 107 will not be included.

2. The term non-volunteer officers as used herein refers to those Reserve, National Guard and Army of the United States officers who have expressed the desire, pursuant to provisions of paragraph 4 E, Section 4, War Department Circular 366, 1945 to be relieved from active duty at the earliest opportunity.

3. War Department message WCL 20702 dtd 17 June 1946 pertaining to separation criteria for Medical Department officers is rescinded.

Desire Continental Army Commanders so inform immediately all installations including class two installations within geographical limits their Army areas.

Diplomatic withdrawal would create vacuum into which Russian influence could move, and consider China a "Challenge to our best Statesmanship". Others argue China is our responsibility because U. S. Concessions at Yalta brought about China's present chaos. Gen. Marshall was praised anew for his patient efforts.

Chiang's V-J day anniversary declaration applauded by but few commentators, who felt it should strengthen position of his Gov't among Non-Totalitarian states and give new impetus to mediation work of Marshall. A steady current of criticism of Chiang and Gov't has continued. Several editorialists impatiently advocate withdrawal of all U. S. support and Military supplies until Kuomintang fulfills its promises. An equally small nbr urge more, rather than less, support for Chiang. While most commentators approve presence in China of U. S. Marines, a speedy end of Military "Intervention" was called for by many labor groups, veterans' organizations and individuals in letters to department.

Paris Conference: Week's first press and radio comment continues to view conference in terms of struggle between Russia and West. Even general debate on Italian and Balkan Treaties discussed primarily in these terms rather than as to content of treaties. Byrnes' strong reply to "Abuse" heaped on U. S. generally treated as pointing up fundamental

conflict at Paris. Support for U. S. position as stated by Byrnes remains firm.

Italian Premier's appearance and following discussion evoked sympathetic support for Italy. Most comment Italy's terms harder than those for Balkans, some allegations Russians protecting their own while America and Britain renege on wartime promises to give Italy a break. Some influential commentators now say CFM'S compromise on Trieste was unjust or unworkable and suggest new approach. Bulgaria's demand on Greece generally dismissed as brazen attempt former enemy to browbeat brave victim Nazi aggression. Little comment on what conference will finally produce but general views are usually gloomy.

Palestine: Lively discussion follows reports President is considering modified federation proposal. Rumors that Jewish Province may receive more autonomy and territory have encouraged observers to restate their support for Federation principle. But "Liberals" are outraged by halt on illegal immigration into Palestine and renew their denunciations of British Policy.

Majority of American Public is sympathetic to Jewish aspirations in Palestine and some commentators have joined Jewish leaders in particularly deploring further delay in admitting 100,000 Jewish refugees. But, opinion polls show sympathy does not go so far as to include sending U. S. Troops to Palestine to "Help England keep order." A few commentators and editorials advocate U. S. acceptance of more refugees as proposed by Truman. Several scattered newspapers suggest UN take over Palestine problems. Observers increasingly discuss Russian pressure on Britain in near East and Russian support of Arab opposition of Palestine proposals.

1. The Armed Forces Leave Act of 1946 provides that on and after 1 September 1946 the amount of accrued leave for officers and enlisted personnel will not exceed 60 days. The term "Leave" shall be applicable to both officers and enlisted personnel.

2. Officers and enlisted personnel remaining in active service after 1 September 1946 will be entitled to compensation in 5 year Government Bonds for amount of leave accrued as of 31 August 1946 in excess of 60 days. Total accrued leave as of this date cannot exceed 120 days. Forms for filing claims available about 1 September 1946.

3. On 1 September 1946 and thereafter all officers and enlisted personnel are entitled to accrued leave at the rate of 2½ calendar days per month, credited as of last day of the month, not to exceed 60 days and must receive such leave prior to their separation or discharge.

4. Enlisted personnel separated or retired from active duty prior to 1 September will be compensated in Bonds for full amount of accrued leave, less leave taken. They will make claim for such compensation following their separation or release. Forms for settlement to be available at Post Offices.

8. All regulations and instructions in conflict with those herein are hereby rescinded. Revised leave regulations will be published soon. (Desired Continental Army Area Commanders so inform all installations, except class 3 installations, with geographical limits their areas; desired continental Major Army Air Force installation Commanders so inform all class 3 installations under their respective commands. IEC GBC BBC AND ABC notified direct).

The necessity for maximum utilization of limited housing facilities for dependents in overseas areas and the additional administrative problems involved, requires that the following procedure be applied when port calls are refused by dependents or delay is requested. Delays up to 30 days are authorized without explanation. Refusals of port calls or requests for delays of over 30 days will, unless an acceptable reason is offered, necessitate the cancellation of the dependents priority by the port and reapplication by the overseas personnel concerned. Port commanders will advise the Adjutant General, Chief of Transportation, the ZI Army concerned and the overseas commands concerned of any cancellations. Dependents will be advised of these provisions by the ZI Armies when such refusals are received or delays are requested. Overseas commanders will give widest distribution and publicity to these provisions.

Effective 1 September 1946, insertions into established priority lists received after the 15th day of the month preceding the effective month of such lists will not be made. Such insertions when requested after that time will be placed on 1st priority of movement for the next subsequent personal recommendation of the Theater Commander or the Assistant Chief of Staff concerned.

Richard J H Johnston, in New York Times (5 August) dateline SEOUL August 3, reports the jubilation with which Korea welcomed her "liberation" a year ago has been replaced by disillusion. "Geographically divided at the 38 parallel and politically bisected by two dissimilar systems of government, this nation of twenty eight million is the unhappy testing ground of United States-Soviet Relations," Johnston writes. He adds that out of the failure of the two occupying nations to settle even the most minor mutual problems has come the question that is on the lips of every Korean: "What is to be done with and for Korea?" Johnston says Korean farmers are not cooperating with Military Government to end black market, but "find it more profitable to do business in secret rather than turn in grains at set prices."

AP Washington August 4 quotes Kilsoo K Haan, Washington representative of the Sino Korean Peoples League as saying that Koreans were helplessly torn by the United States Russian occupation, and were "unwilling parties to the making of a third World War." Haan is quoted as saying "It is my sincere and considered conviction that the majority of the Koreans in Korea desire an early removal of all United States Soviet occupation forces from Korea."

B. Not certain what is meant by "Constructive. Credit be given for total overseas service since 7 December 1941" our plan is to distribute equitably overseas service. However this equitable distribution will take several years. While it is desirable, it is not believed practicable to give credit for combat and arduous service in undesirable locations in contrast to normal peace time conditions when families can accompany officers.

C. No. We intend that hereafter when an officer is ordered overseas he will be overseas for a full foreign service tour or until expiration of volunteer retention statement.

3. Circular 383 and proposed revision thereof give Theater Commanders the right to use their own judgement in considering exceptional cases of long overseas service involving arduous conditions or periods in ZI slightly in excess of 6 months. In this regard all personnel now being ordered overseas have served from 15 to 25 months overseas since 7 December 1941 depending on their grades. Serving a minimum of 6 months on present tour is not adequate in view of personnel now being returned overseas with long tours of

Newsfile material: Woman Paris July 31. A woman presided over the French National Assembly July 30 for the first time in history, a dispatch to the New York Herald Tribune said today. She was Madelene Braun, Deputy from Paris, who holds the rank of a Vice President of the Assembly. As such, she was eligible to substitute today for the Assembly's regular presiding officer, Vincent Auriol, who is ill. Mrs Braun, 39, is not only a member of the Assembly but a newspaper editor, musician, artist, social worker and former law student. A member of the Communist Party, she was elected to the Assembly in October, and was reelected last month. During the war she was active in the resistance movement. Dressed in a plain black dress, Mrs Braun made her entry with the usual ceremony accorded the presiding officer. Ascending the speakers stand, she rang the speakers bell decisively and called for silence. Her male colleagues broke out in loud spontaneous applause, and the historic session was opened. Mrs Braun is also the first woman ever elected to a vice presidency of the Assembly team.

Newsfile Material: Police, Paris, July 31. A group of French police is on hand around Luxembourg Palace and throughout Paris to assure that the Peace Conference will proceed with regard for delegates' safety and convenience. A dispatch to New York Times reported 31st Palace area has been organized into special precinct with 150 men on duty as well as a number of ceremonial Republican Guardsmen and some members of both Judicial Police of Paris and Surete Nationals. All uniformed men wear red shoulder cord of Legion of Honor battle citation won by entire Paris police force, which arose and trapped German detachments in police prefecture and elsewhere when Allied troops entered Paris. Times said police details of conference are under direct supervision of Charles Luizet, prefect of police of Paris, who led the police in their assault on German-held points during battle for Liberation. Detachment of Luxembourg is commanded by Georges Maurice, old time police precinct captain whom Luizet made chief of uniformed force for his work in the resistance. He is a "stickler" for discipline and Luxembourg detail is smartly turned out.

Newsfile material: Conference Paris 31st Russian Foreign Minister Molotov, speaking before 3rd Plenary Session of European Peace Conference here 31st voiced determination of Soviet Union that 21 nations shall have "Equal rights to express themselves freely and openly on any treaty" and asserted that "Any view expressed here will be heard with respect and eventually will be weighed with due consideration" Molotov said the Soviet Union greets "Peoples of Allied Countries who fought with self denial against our common enemies and expresses its firm determination to support them in their just demands for punishment of War Criminals, indemnification of damage caused them and establishment of just peace" Soviet Foreign Minister said Council of Foreign Ministers had not satisfied aspirations of all Allied Peoples but that attacks on councils decisions were by those "Who hoped cooperation among Big Powers would not continue", and he reminded such critics that the former enemy countries had waged aggressive war against democracies on side of Germany and Italy and had caused untold suffering in Russia, Poland, Yugoslavia, Czechoslovakia and Greece. Molotov added however that Soviet Union opposed any attempts to impose on exsatellites of Germany outside interference in their economic lives describing such attempts as "Pressure which is incompatible with Countries Sovereignty and National Dignity." Molotov told delegates that "It is impossible to safeguard peace unless fascism is destroyed." And renewing Russias warning that Spain constituted threat to world peace, he commented: "If we still have to deal with question of Fascist Regime in Spain then time must not be too distant when Democratic Countries will be able to help Spanish People who groan under Franco's Regime to put end to this survival bred by Hitler and Mussolini which

is dangerous to cause of peace." Australian Foreign Minister Herbert Vere Evatt followed Molotov in speaking before 3rd Plenary Session with demand that 4 principal powers agree to accept conference recommendations and that all nations have equal voice in treaty making. "Each of 21 Nations" Evatt declared "Must have equal rank and voice in this conference. Real question which concerns us is whether consultation by Major Powers Represents full extent of our rights. Right of making the peace should belong to all those who have been partners in achieving the common victory." Earlier at meeting of Committee on Rules the procedure Evatt had vigorously sought to have simple majority rule established for conference. Evatt told committee meeting to settle procedure under which Peace Conference will conduct its business, that 2/3 majority should prevent anything of importance from being decided by General Peace conference that had not already been decided by Council of Foreign Ministers. Australian Foreign Minister pointed out that simple majority rule would enable middle powers to play their full roles in shaping the peace. He made 2 recommendations to committee—that recommendations of countries that fought in war be brought before Council of Foreign Ministers and that no final decision on any part of procedure be taken at this stage of discussions. Netherlands Delegation also opposed any decision to establish 2/3 majority rule. Soviet Foreign Minister Molotov told committee that "If all decisions were by simple majority, USSR would be sure to find itself in minority." He predicted that there was every possibility the conference could reach each termination with every proposal adopted by 2/3 rule. Dispatches quoting unnamed American sources said that at next meeting of committee US Secretary of State Byrnes will offer compromise plan providing that all substantive proposals which failed to secure 2/3 majority should be sent by conference back to council of Foreign Ministers along with names of countries which voted for it and with request that council give measure special consideration. Hot Springs Arkansas July 31st. Because of physical disability Lt Gen William Hood Simpson, Commander of US 9th Army which saw action in Germany and France, has been recommended for retirement it was announced on 30th.

New York 31st. New York City Postmaster Albert Goldman announced that postal administration of Poland will now accept articles sent from United States in form of packets. He explained packets are limited to 2 pounds 3 ounces in weight.

Washington DC July 31st. Doctor Helen Dwight Reid, International Affairs Specialist of American Association of University Women and former Professor of International Law at Bryn Mawr College in Pennsylvania, has been named acting director of National Committee on Atomic information, Doctor Ralph MacDonald, chairman, announced. She succeeds Daniel Melcher who resigned. Committee was set up by 60 national organizations in December 1945 to cooperate with Atomic scientists in an Atomic energy educational program.

San Francisco Calif 31st. Henry J. Kaiser, industrialist, and Doctor Herman Kabat announced that they would establish Kabat-Kaiser Institute for Neuro Muscular rehabilitation in Washington DC as aid to paralysis victims. New York 31st. Louis Adamic, author of "A Nation of Nations" has written an intimate picture of friendship between late President Franklin D Roosevelt and Winston Churchill in his forthcoming book entitled "Dinner at White House" which will be released by Harpers August 28th.

Washington 31st. Senate has approved legislation to establish Theodore Roosevelt National Park near his former cattle ranch in North Central State of North Dakota. Senate also authorized 350,000 marks for monument of former Republican President at nearby Medora North Dakota.

Berlin 31st. 4 Allied Occupation Powers have decided to dissolve Kaiser Wilhelm Society, one of worlds famous scientific research organizations. Agreement said that some of laboratories of societys 38 research institutes will be permitted to open for peaceful scientific research even though society is dissolved. Society was founded in 1911. Professor Albert Einstein was director of Kaiser Wilhelm Institute for physics before he went to United States.

Washington 31st. Lt Gen Harold L George CG announced that Maj Gen Robert M Webster, formerly Commander of European Division, Air Transport Command, has taken over post of acting deputy Commanding General of ATC. General Webster replaces Brig Gen William F McKee who has gone overseas to head UP European Division.

Frankfurt 31st. Lt Col James R Pappas, Public Health Officer for Military Government, said there was an increase of 120% in tuberculosis cases in American Occupation Zone during last 5 months.

Washington 31st. 4 Czechoslovakian journalists are being entertained here as guests of State Dept. Completing 7 week tour of United States guests are Miss Alena Bernaskova, Jan Trachta, Frantisek Neloun and Karel Zieris. Among many activities planned for visitors were to meet 2 Czechoslovakian-born United States legislators, representatives Adolph Sabath of Illinois and Karl Stefan of Nebraska. Journalists will depart for New York August 3rd.

Caracas Venezuela 31st. Admiral William F Halsey was decorated by Venezuelan Government on 30th as Grand Officer of Order of Liberator. Admiral Halsey who is making good will tour of Latin America, was entertained at reception and banquet at Embassy by American Ambassador Frank P Corrigan.

New York 31st. At request of United Nations Food and Agriculture Division, Adan Lunoe, news editor of NBC International Divisions Danish Section, will fly to Denmark to act as information officer for organizations World Conference which opens in Copenhagen September 2nd.

Tokyo 31st. General Douglas MacArthur announced on 31st he has taken steps to reopen trade and commerce between Japan and other Eastern Countries. He invited purchasing commissions from Singapore Malaya Hongkong Burma Ceylon Borneo China and India to visit Tokyo. All transactions will be conducted on Government to Government basis. Governments of India and China already have agreed to negotiate with General MacArthurs Headquarters for Japanese products in return for commodities urgently needed in Japan.

Oxford England 31st. Atomic Scientists Association Conference has agreed to establish international clearing houses in New York and Paris for exchange of information on Atomic energy and developments. It will write scientists of all countries in which there are scientific organization to try to bring about an inter-change of ideas and information between atomic scientists.

New York 31st. Mrs. Ruth Warters Reich has been sworn in by Mayor William Odwyer as Justice of Domestic Relations Courts at salary of 120,000 marks yearly. Mrs. Reich, former President of Brooklyn Womens Bar Association (Local Legal Organization), served as an assistant attorney general of New York State from 1931 to 1943.

Rio De Janeiro Brazil 31st. More than 1,000 passengers aboard transport Duque De Caxias which left Rio on 30th for Europe were being rescued by 2 British ships on 31st as fire broke out aboard ship. Transport which had brought Brazilian Expeditionary Force back from Italy, is reported given up as lost.

New York 31st. Widespread starvation in Far East during coming year may result as much from lack of transportation equipment and funds as from scarcity of food according to Far Eastern Survey Report. Report said food shortage in Orient is worse since end of war owing to cumulative deterioration of agriculture. Adverse weather conditions for current crops especially India Burma and Japan also contributed to shortages. Other factors listed included lack of sufficient foreign currency, insuperable problems of transportation and political uncertainties.

Washington 31st Army Signal Corps disclosed 31st that it is using radar to help get information about wind conditions nearly 20 miles above earth. Balloon equipped with reflector surface of aluminum foil is traced by radar as balloon ascends. Formerly all information about prevailing winds at various altitudes was gathered by visual observation of free balloons. New method makes it possible to take observations even in darkness or bad weather.

Tokyo 31st 2 typhoons which originated as one storm in Marianas last week reported dying out on 31st. Storms disrupted railway, shipping and telephone communications in various parts of Japan as well as causing heavy damage to rice vegetable and fruit crops.

Washington 31st Joris Ivens documentary film of China early resistance to Japanese aggression "Four Hundred Million" was revived 30th in special showing sponsored by Washington Post and Washington Public Library. Film, produced in 1939, is comprehensive cross section of life in China. Frederic March, stage and screen star, delivers commentary written by screen writer Dudley Nichols.

New York 31st 14th and final volume entitled "Seventh of October" of Jules Romains "Men of God will" series will be published by Knopf November 14. Book gives kaleidoscopic picture of crisis in France in 1933.

Newsfile material: Farms Chicago July 31st 1st National Conference to bring to American farmer complete knowledge on use of electricity to improve and increase production and raise his standard of living while lowering his costs will be held in Chicago early in November of this year more than 8 National Agriculture and Engineering groups will participate in meeting which was conceived by group of agricultural engineers. Both U.S. Dept of Agriculture and Office of Education will be represented at Conference New York Herald Tribune reported 31st that Russell J. Gingles manager of Farm Electrification Bureau of National Electrical Manufacturer Association in announcing meeting on 30th said: "Our main purpose in calling the meeting is to lay the groundwork for the complete education of the farmer on the use of electricity. While majority of the nations farms are now electrified, only small percentage of farmers are making use of the equipment or facilities available to them". Gingles pointed out that with the War and the consequent shortage of farm help there came realization that electrical energy could become an extra farm laborer as well as servant in home. Need for conference within near future became apparent NEMA official said when survey disclosed that suppliers of electricity expect to complete almost all line construction some time during 1948 Gingles said that agricultural specialists predict that most electrified farms will be using twice as much power by 1950 as they did in 1942. More than 3,000,000 of Americas 5,950,000 farms now have electric power.
