

SUBJECT: Unpaid Wages for Civilian Drivers

TO: The Commanding General  
Philippines Ryukyus Command  
APO 707  
ATTENTION: Chief of Claims Service

1. The civilian drivers attached to the Philippine Motor Transport were in nearly every case conscripted from local transport companies on Luzon. These drivers accompanied their trucks, busses and cars to Bataan and were assigned to various motor pools. Wages in general were approximately two pesos and fifty centavos per day. There were exceptions, however among individual drivers, but I do not remember names of individuals.

2. All payments of drivers were made from Headquarters of Commanding Officer, Colonel Michael O'Quinn (now Commanding Officer, Kansas City Quartermaster Depot, Kansas City, Missouri). As I recall many of the drivers of the Motor Pool were paid only once, that being in February 1942. What period this payment covered, I do not know. In no case do I believe that any driver received more than payments for a thirty day period.

Dear Captain Pulley:

I wish to acknowledge your letter of 7 January with regard to the claim of Francisco D. Moraleda.

I do not recall this man, but to the best of my knowledge his claim is justified. He was, no doubt, originally employed by the Army through the office of the Philippine Motor Transport Depot in Manila.

I was assigned to Motor Pool #4 on 2 January, 1942 and remained there until 12 January, 1942, at which time I took command of Motor Pool #6 I Philippine Corps. Therefore, from that date to the fall of Bataan on 9 April 1942, I would have no personal knowledge of the man.

Wages paid these drives was at the rate of \$1.25 (2.50 pesos) per day, and it is my belief there were not paid beyond 31 December 1941.

Additional information concerning this man's employment can be obtained from Captain Fran F. Burgess now stationed at the Presidio, San Francisco. Captain Burgess was second in command at Motor Pool #4.

2. I do not recall the rate of pay, but wages paid these drivers were comparable to wages paid by local transportation firms at same period. I believe all drivers were paid the same amount, regardless of ability or seniority status with their local employer.
3. All payments were made by a civilian paymaster under direction of Colonel M. Quinn, Commanding Officer of 12th Quartermaster, U.S. Army on Bataan. There were a few exceptions where the Motor Pool Officer made some partial payments.
4. With no roster available, I cannot identify the names given, except Juan S. Solis, as having been connected with Motor Pool #4. They could have been, as I had over one hundred (100) drivers.
