

That he personally knows Geronino N. Santizo, Mho. was a "Quartermster" or "Helmanan" on the M/3"KATIPUNAN" even long before the war broke out and until the said M/S "KATIPUNAN" was souttled off Cagayan, Oriental Misamis, on May 3, 1942.

That said Geronimo N. Santizo was drafted into the United States Armed Forces by the USAFFE to continue serving as Quartermaster on the M/S "Katipinan" until said ship was scuttled on May 3, 1942, at the monthly salary of \$80.00; that said Geronimo N. Santizo was not paid his salary for the period covered from February 15 to May 3, 1942.

That affiant personally knows all the foregoing facts because he was the Captain of the said M/S"Katipunan" long before the war broke out and until said vessel was scuttled on May 3, 1942.
