Memo for Lieut. Thacker:

In accordance with your request I am attaching hereto a tabulation of overtime services rendered by civilian employees of the Procurement Division, Engineer Office, Manila, during the months of June 1941 to December 1941 inclusive. These names and figures are from overtime reports submitted at the end of each month by the Procurement Division to the Engineer Office, and were copied from the files of these reports before these files were destroyed immediately prior to the Japanese occupation of Manila.

The Procurement Division began submitting these reports with the month of June 1941, on instructions from Lieut. Col. Roscoe Bonham. However no payment had yet been made, or compensatory leave granted, prior to January 1, 1942, for these overtime services.

This tabulation is certified as a correct copy of the original reports as to names and numbers of hours of overtime service rendered each month.
