That I was the Capataz for the 14th Engineer, USED, USA, from January 10, 1942, until the surrender of Bataan on April 9, 1942; that we were under the direct supervision of Lt. Teodoro Utrate, that our paymaster was Lt. Stewart; that our work in the said outfit was the construction of trails; that as far as I can remember we worked on trails Nos. 36, 46, 2, 8, 10, Orion, Limay and Bagae and Aglaloma vicinities; that I received a daily wage of P2.00; that as far as I can remember, the following persons worked with me:

That I was employed by the 14th Engineers Labor Battalion USED, on or about 10 January 1942, to 9 April 1942, in the capacity as foreman; that our works in the said outfit were constructions of trails and bridges and filling up bombed trails during the war in Bataan front in the year 1942; that we worked on trails Nos. 2, 4, 6, 8, 10, 36, 38, and 48 at Orion, Limay and Bagac vicinities; that the laborers were paid a daily wage of one peso and twenty centavos (Pl.20); that as far as I can remember, the following men listed herein, worked under my immediate supervision when employed as Foreman of the said outfit:
