FIRST ENDORSEMENT

To: Captain George F. Smith, Claims Investigating Service, AFWESPAC Office of the Chief of Claims

- 1. In reply to the request made of me in the Basic Endorsement, I am setting forth the following facts:
- 2. I was with Walter Cushing in December 1941 in Abra. I lived with him for about a month until we both left this area for Ilocos Sur and the Mountain Province. During this period Walter Cushing, later a Major, used his own Chevrolet Sedan which he had at his mine near Baay in Abra. During this same period Mr. Santos, the Division Superintendent of Schools, was using his own sedan car, and to the best of my knowledge his car was never commandeered by Walter Cushing. Major Cushing and I left Abra about the middle of January 1942 with Mr. Santos still in possession of his car in Abra. Although I never returned, I know that Major Cushing did return at a later date, but that when he returned the Japanese had already entered the province and were in complete control of all of the inland road systems. Accordingly, it seems impossible to me that Major Cushing would have commandeered the car at a later date. It is more likely the car was commandeered by the Japanese.
- 7. The above facts are still vivid in my mind, and if I were required to approve the claim of Mr. Roman L. Santos, I should like first to see a receipt signed by Major Cushing for the Studebaker Cruising Sedan car which Mr. Santos claims was commandeered. To my best knowledge Major Cushing gave receipts whenever he commandeered personal property from civilians.
