I, Victorino P Tulio, Captain of the S/L Danao (now the L/S Bata-an) do hereby certify that the above listed men were serving aboard said vessell at the outbreak of the war and were still serving in the above capacities at the time the boat was taken over by USAFFE. They continued their service from that time (date unknown, December 1941) until March 5, 1942 when I was ordered to abandon ship at Iloilo City.

That I and my crew were last paid in full to include 5 March 1942, by Mr. Marshall, of the Visayan Stevedore transportation Co.

That my vessel was engaged in towing lighters between Iloilo and Bacolod. That said lighters were loaded with ammunition and other supplies.

That after 5 March 1942 I returned to/Capez, where I ~~XXXX~~ evacuated my family to the Mountains. We stayed there for about twenty-two days and then moved to/Batan, Capiz where it was thought we would be more safe. After about seven months I returned to Altvas and made my living by making soap. I stayed there until the return of the American forces.

That lack of fuel was a determing factor that caused us to abandon our ship.

AFFIDAVIT

I, Brigido **Gentiles**, Patron of Motor Launch "C. Danao", do hereby certify that the following statements are true and complete to the best of my knowledge:

That I first started to work for USAFFE on 16 January 1942, by order of Capt. Xaudaro, port Captain of Iloilo.


That aboard said launch I had four men serving on deck and three below, but I remember the name of only one man, Chief Engineer, Alejandro Dalida.

That I and my crew were paid in full on 14 April 1942, by Capt. Xaudaro, Port Capt. of Iloilo. That said crew served continuously.


That said launch was used to tow barge between Iloilo and Bacolod.

That on the morning of 16 April 1942 said launch was tied in the harbor of Iloilo. That about 7:00 we abandoned said vessel and fled to the mountains; Motor Launch remained intact when we left, and I do not know what ever became of said launch.

That from that day on I fled to the hills and engaged in buying selling food stuffs. Am now unemployed.
