1. The following guerrilla unit is recognized by the Commander-in-Chief, United States Army Forces, Pacific, as an authorized element of this command effective as of the date specified:

2. Unit will proceed to Camp Murphy, Luzon, reporting upon arrival to the Commanding Officer for processing and assignment, at a future date to be established by this headquarters.

3. Under the provisions of Executive Order No. 21, by the President of the Commonwealth of the Philippines, dated 26 October 1944, the status of members of this unit is that of officers and enlisted men of the Philippine Army.

4. It is desired that payment of this unit be facilitated by Finance Officers of the Philippine Army.

5. It is desired that the name of Wm P. Smith, be added to the HQ roster of Hunter's ROTC Guerrillas in grade of First Lieutenant with date of recognition as of 31 January 1945.
