

Area effective 1 May 42.

- 5. A comparison of SO # 13 with 1942 orders of the 81st Division Area, presently on file in Records Section, and which contains orders subsequent to the date of the order in question, shows SO # 13 to be compatible in all respects.
- 6. Of the 10 individuals involved 2 are negative to VA. One was previously certified positive and later changed to negative (probably could be adjudicated positive on basis of current policy). The other negative to VA was positive for guerrilla service. Guerrilla archives indicate S/I was a USAFFE of the 81st Division and it also appears that it too could be determined positive for USAFFE service.
- 7. It is recommended that the attached copy of para 3, 4 and 5, Special Orders number 13, Lanao Sector Force, 81st Division Area, In the Field, dated 22 May 42 be accepted as authentic, since the majority of individuals allegations are compatible with the order in question regarding name, rank and organizations, seven of the ten have sufficient archives to establish service and the order is compatible in every respect with those on file.


