1. This project initiated to verify authenticity of roster, Philippine Army Signal Corps, Ft. Mills, Corregidor, 1 May 1942, located in Project "J" file 500-5-4.

2. Roster lists names of 25 PA personnel. 201 files for 23 of 25 listed contained positive certifications of USAFFE (VA or WCC). Alleged ranks, organizations (components of PASC), commanding officer, date and place of service numbers correspond with roster involved. Ten files reveal service numbers consistent with those shown on roster. Ten individuals alleged induction during period 20-26 Feb 42 (others alleged Sep-Dec 41). Their files contain copies of WD Civilian Payroll, Signal Corps, In the Field, Bataan, Mar 42, showing they were paid as civilian employees for period 1-19 Feb 42, and inducted into PA 21 Feb 42 per verbal orders of Commanding General, USAFFE. Six of these files also contain Medical Records Mar-Apr 42, showing USAFFE status.

3. The signature of Manuel E. Galvez, Captain, Sig-C, PA, Commanding, is compatible with that shown in his 201 file. His file indicates he was assigned as Assistant Chief Signal Officer, PA, at Ft. Mills, Corregidor during period 15 Feb 42 to 6 May 42. Records show he received medical treatment at Malinta Tunnel, Ft. Mills Corregidor on 18 Feb 42.
