

Order was forwarded to this office by the Veteran's Administration for use in the case of Juan S. Tubac by letter 7 January 1954.

2. There are five paragraphs (45-46-47-48-49) of Special Orders 144 on file with USAFFE-PA Archives (300.4 F 19). Paragraph number (32) appears to fall in correct numerical sequence since paragraph 45 pertains to Hq & Hq Co 3rd Bn, 72nd Infantry and paragraphs, in ascending numerical order, pertain to Companies I, K, L, and M.

3. All paragraphs on file and paragraph under study contain mimeograph signature of S. R. Menchavez, 1st Lt., FA-Res Asst. Adjutant. Mimeographed signature appearing on Paragraph 32 is compatible with others appearing on the separate paragraphs.
