1. Extract of SO #175 (Par's 11-21), General Headquarters, Armed Forces of the Philippines dated 28 July 1951 was located in 201 file of Pfc. Felipe A. Margallo. Par's 13, 14, and 15 confirm reversion to inactive status or discharge of four PA personnel on or prior to 30 June 1946.

2. 201 files located for the four individuals involved. Name, rank, and home address in 201 files consistent with SO #175. Three allege same dates of discharge as shown in orders, the other, whose 14th Inf. AUS status was revoked, alleges a different date of discharge.

3. A comparison of SO #175 with other Special Orders of same organization for January and May 1951, on file in Records Section, show they are compatible regarding format, organization title, location, command line, and signature.
