1. This project initiated to verify authenticity of Par 80, Special Orders #155, Headquarters 2nd Military District, DND, Commonwealth of the Philippines dated 14 July 1941. This extract of Special Order #155, submitted in the case of Matias R. Ferrer, contains the names of 110 PA personnel called to active duty effective 23 November 1941 for assignment with Company I, 23rd Infantry Regiment.

2. A search of 201 files for approximately 40 names listed resulted in the location of 21 files pertaining to individuals shown in orders. 13 of these files contained information indicating the individuals died prior to return to military control. Except for one individual, alleged rank and organization is consistent with orders. 13 of the 21 alleged induction during period 23 - 27 November 1941, one alleged 16 November 1941, three during period 3 - 15 December 1941, and the remaining four (all death cases) failed to show date of induction. 14 of the 21 files contain positive USAFFE determinations.

3. A comparison of Par 80, Special Order #155 with other paragraphs (24, 42, 55, 63, 66, 75, 81, and 83) of Special Order #155 on file in Records Section, shows they are compatible regarding format, organization title, location, date, command line, and signature. Paragraphs 75, 81, and 83 pertain to Companies E, K, and L, 23rd Infantry Regiment and also show effective date of call to active duty as 23 November 1941.

4. Recommend that Par 80, Special Order #155 be accepted as authentic, that order be indexed, cards filed in Master Card File, and copy of order be filed under Decimal File 300.4, Folder 42.
