

- (l) **Remarks:** Gains will be indicated under remarks, together with other information considered essential by the Commanding General of the force or command concerned.
- The roster of nurses, including remarks pertaining thereto, will be submitted on separate roster sheets, W.D., A.G.O. Form No. 8-164, firmly attached to the report.
