

3. It has been alleged that the offenders are members of the 4th Prov Regt. It must be ascertained to which Battalion or Company they belong.

4. Attached herewith is the descriptions of the offending parties furnished by alleged eye witnesses.

5. All Jap firearms in the possession of any member of each outfit must be accounted for and an inventory thereof be submitted to this HQ.

6. Report of your findings must be submitted to this HQ in triplicate within 72 hours upon receipt of this order.


