Pvt Gaudencio Pused, Inf was killed by enemy
rifle shot that pierced thru his stomach and body
causing his death during the encounter against the
enemy at Aawayan on October 19, 1944. Same EM is
cited for good conduct and bravery in the face of
the enemy.

- (2) Name:----- Pvt Juan Modequillo, Inf
Organization:----- Company "M", 86th Inf
Cause of Death:-- Enemy mortar shell splinter
Date:----- October 19, 1944
Remarks:-----

Pvt Juan Modequillo, Inf was KIA during the
enemy encounter at Agbagon Ridge on October 19,
1944, by a splinter from the enemy's mortar shell
hitting him on his lower jaw which later caused
his death. Same EM is cited for good conduct and
bravery in the face of the enemy.

- (3) Name:----- 2d Lieut Guillermo Cinco, Inf
Organization:----- Hq & Hq Co, 2d Bn, 86th Inf
Cause of Death:-- Killed by Japs Patrol in Estaca,
Compostela
Date:----- October 8, 1944
Remarks:-----

2d Lieut Guillermo Cinco, Inf was killed ins-
taneously by a gunshot that traversed his chest
diagonally from left to right by the Japs patrol
in Estaca, Compostela while Lt Cinco was on his
way to Dango on procurement mission. He was killed
"IN LINE OF DUTY".

- (4) Name:----- Sgt Pedro Cugay, Inf
Organization:---- Combat Co, 86th Inf
Cause of Death:-- Captured and killed by the Japs
Date:----- September 6, 1944

Remarks:

Sgt Pedro Cugay, Inf was captured by the Japs in Jubay, Liloan while on mission on September 2, 1944, and found dead by civilians in Cabangcalan, Mandawe on September 6, 1944. He died "IN LINE OF DUTY".

- (5) Name:----- Sgt Benedicto Barriga, Inf
Organization:---- Combat Co, 86th Inf
Cause of Death:-- Influenza, Intestinal Type
(Severe Gastritis)
Date:----- September 19, 1944

Remarks:

Sgt Benedicto Barriga, Inf died of Influenza, Intestinal Type (Severe Gastritis) at 6:45 PM, September 19, 1944, at A-1 Base Hospital, 86th Inf. He contracted the disease "IN LINE OF DUTY".

CASUALTIES (WIA)

Cause of wound:-- Enemy bullet
Date:----- October 17, 1944

Remarks:

Pvt Antonio Espinosa, Inf was hit by an enemy bullet which entered below the right anterior superior iliac spine, 1/4" in diameter during the enemy encounter at Pangyao, Compostela on October 17, 1944. Same enlisted man is cited for good conduct and bravery in the face of the enemy.

Wounded In Line of Duty

Cause of Wound:-- Sharp Stone
Date:----- October 17, 1944

Remarks:

Pvt Doroteo Delica, Inf was hit on the knee by a sharp stone on October 17, 1944 after the enemy encounter while withdrawing from Dagongdong. His case does not merit any citation but considered "IN LINE OF DUTY".

Cause of Wound:-- Knee hit by rugged rock
Date:----- October 18, 1944

Remarks:

Corp Ildefonso Brocoy, Inf was wounded during the last enemy penetration (Oct 17-21) when the troops withdrew to the Bn CP, 1st Bn, 86th Inf
