## b. Subtask b:

(1). Principal demolition: Destroy one of the main steel bridges above Camp 4 as close to Baguio as possible using dynamite and leave detachment thereat with mission of (same as Par. C. 1. a. (1) above.). Size of detachment: Same as Par. C. 1. a. (1). above.

(2). Additional demolition: Destroy road by causing slides in the vicinity of Camp 6 using dynamite or any other possible means.

(3). Additional demolition: Destroy two wooden bridges above the junction of the Kennon Road and Loacan Airport Road on the Kennon Road by burning and/or use of dynamite.

(4). Additional demolition: Destroy two wooden bridges on the Loacan Airport Road between Loacan Airport and the Kennon Road by burning and/or use of dynamite.

(5). Additional demolition (if dynamite is available): Destroy or block road by causing slides on Zig-Zag using dynamite or any other possible method.

(6). In the event that principal demolition, (1) above, is not successful, detachment of (1), with same mission as (1) above, will be stationed at (2) above. Note: Same as (1) as (1) above.

(7). Cut and remove at least two one hundred yard sections of telephone and telegraph (if any) lines at the following places:

(a). Between Military Cut-off and Kennon Road-Loacan Airport Road junction.

(b). Between Loacan Airport and Kennon Road Loacan Airport Road junction.

(c). Between Camp 7 and Camp 6.

(d). Between Camp 6 and Camp 4.
