1. LOCATION OF TROOPS:

121st Inf moving to vic BAUKO
15th Inf:

2. WEATHER AND VISIBILITY:

Intermittent rains in the afternoon, clear in the morning;
visibility fair to good.

3. OUR OPERATIONS FOR THE PERIOD:

a. Summary:

In the CERVANTES area, 121st Inf remained in training areas vic TUE at start of period and initiated movements toward BAUKO to follow advance of 15th Inf. 15th Inf continued attacks NE and following artillery preparations, seized OTUKAN (69.7-56.8), 4700 yds W SABANGAN against moderate enemy resistance, 080700 July. Combined elements of 15th Inf and 1st Bn, 11th Inf attacked

and occupied enemy positions on crest of MT AMO with heavy opposition, killing 26 Japanese, 071400 July, followed by capture of high grounds 2800 yds and 2900 yds NW BAUKO by 3rd Bn, 15th Inf against weakened enemy resistance, 071700 July. 66th Inf repulsed 2 enemy night attacks 1200 yds NW LEPANTO and continued converging attacks on LEPANTO and MANKAYAN, occupying enemy positions on high grounds 1200 yds and 250 yds W LEPANTO and securing W slope of ridge 1100 yds NE MANKAYAN against strong resistance. Co F, 127th Inf (US) operated normal security patrols around battery positions, 694th FA Bn. 694th FA Bn (less Btry C) with 1st FA Bn and Btry A, 121st FA Bn fired preparations in support of 66th Inf and 15th Inf. Co A, MP Bn reported strong enemy concentrations vic DANTAY (77.1-65.8), 4000 yds SW BONTOC. 1st Engr Bn continued clearing Hwy #4 eastward following advance of 15th Inf.

b. 121st Inf:

At start of period, regt continued training in areas vic TUE and initiated movements E following advance of 15th Inf at later part of period.

c. 15th Inf:

1st Bn resumed attacks NE from BAUKO, Cos C and D seizing and occupying OTUKAN (69.7-56.8), 4700 yds W SABANGAN following close artillery preparations against moderate enemy resistance, 080700 July. Mopping up operations vic OTUKAN by remainder of Bn still in progress. Cos K and L captured and occupied high ground 2900 yds NW BAUKO against weakening enemy resistance, 071700 July. Co M secured high ground 2800 yds NW BAUKO, 071230 July, meeting moderate opposition. Late reports state Co G repulsed a strong Japanese counter-attack at PINGAD (73.5-52.8), 4200 yds S SABANGAN with undetermined results, 070200 July. Patrols killed 15 Japanese and destroyed 1 enemy truck and 1 bullock cart 2200 yds N PINGAD. Co A, 11th Inf with Co I, 15th Inf, following mortar barrage, attacked and seized crest of MT AMO (62.45-57.85), 071400 July with heavy opposition, killing 26 Japanese. 1st Bn (less Co C), 11th Inf mopped up LUBON - BAGNEN and MT AMO - LUBON areas with unreported results. Co D completed movement to BAGNEN and secured air strip vic (70.0-62.0).

d. 66th Inf:

1st Bn (less Co D) continued aggressive attacks generally E with Co A reaching positions 1200 yds W LEPANTO against increasing resistance, 080700 July, with attacks still in

A. DISPOSITION:

"A" Company - No change

"B" Company after establishing its HQ at SUYO will effect the following changes in the distribution of its unit as follows:

- 1 Squad at the control station and security of SUYO BRIDGE.
- 1 Squad to secure the OH Bodega at SUYO.
- 1 Platoon and 1 Officer at the control station at HUTAC BRIDGE and for the security of HUTAC and vicinity.
- 1 Squad to be distributed among the wooden bridges from SUYO to HUTAC size of security depending upon size and tactical importance.

"C" Company - No Change

"D" Company - No Change

"E" Company, 14th Inf. attached, will establish its HQ at CERVANTES near the MALAYA BRIDGE (Cervantes bridge) and will make the following disposition of its units:

- a. Establish a control station at PARACAC PT.
- b. Establish a control station at BESSANG PASS and secure BESSANG and vicinity.
- c. Provide security of MALAYA BRIDGE and vicinity.
- d. Establish an "Officer control station" at MALAYA BRIDGE.


"I" Company, 14th Inf. attached will send 2 Platoons with two (2) Officers to BAUKO as security thereat. It will establish interior and perimeter guards and check stragglers and AWOL.

"K" Company, 14th Inf. attached, will relieve the 2 Platoons of Co C (Par) 3 of their duties and responsibility.

B. ACTIVITY
