To All Mun. & Mun. Dist. Treasurers,
Mountain Province, P. I.,

Supplement to Office Circular No. 41 dated June 7, 1918,

the following instructions are hereby issued for your compliance
and guidance:

In view of the infrequent mail communication in the pro-
vince and especially during the rainy season the requisitions of
supplies, accountable forms and cash tickets are often delayed.
It should be mentioned in this connection that in many instances
the above delay is also and mostly due to lack of proper fore-
sight on the parts of the secretary-treasurers in making their
requisitions. To avoid therefore the occurrence of said lack
of foresight, your requisitions should be made three months in ad-
vance, that is quarterly, to allow ample time for securing goods
either locally or abroad if articles requisitioned are out of
stock, to avoid rush requisitions for same or the purchase of
same locally. In the latter case, it is requested that requi-
sitions should be submitted to this office before the purchase is
effected with sufficient and clear reason, of course, to the

Real Property
Declarations by owners.

Circular No. 51
December 10th, 1918.

TO ALL TOWNSHIP TREASURERS,
MOUNTAIN PROVINCE, P. I.

The real property must be declared before the township president where the property is located during the first fifteen days of January of each year (January 1 to 15th.) If the owner fails to declare the value of his property during the first fifteen days (January 1st to 15th), he shall immediately be warned by the councilor of his barrio that, unless he makes his declaration before the thirty first of January, he will be subject to a fine of five pesos, and should he fail to make the declaration within the last fifteen days (January 16 to 31st), the fine shall be adjudged against him by the township-court and shall be collected by the treasurer, or in lieu of the payment thereof, he shall be compelled to work it out on public works.

On the sixteenth day of January, the township treasurers should make a list, in duplicate, showing the names of all owners of real property who failed to declare their property on the fifteenth day of January, and deliver the original copy to each councilor with the request that he notify the owners within his district to appear on or before the thirty first day of January and declare the value of his property before the township president in accordance with the provisions of sections 2395 and 2396 of the Administrative Code of 1917. This notification is very essential and it should be thoroughly explained to the councilors that it is their duty to orally notify the owners of real property residing within their districts, and to write to those residing outside of their districts.

The following suggestions should be followed by each of the township treasurers:-

1. He should see that he has always sufficient quantity of supply of real property declarations during the months of December, January and February of each year.
The township treasurers are enjoined not to find themselves out of the necessary forms during the period of the presentations of declarations of real property fixed by law.

2. He should request his president to notify weekly, by means of bandillo, during the prescribed time within which declarations of real property should be filed, to all owners within his township.

3. He should also make similar request to all councillors, and after the fifteenth day of January he should furnish each councillor with the list as prescribed in the third paragraph of this letter. He should also see that the councillors send a notice in writing to the owners of real property residing outside of his district.

It is thought that, by following the above suggestions, further and future complaint about the owners' not being notified, will be avoided.

In this connection attention is invited to the instructions contained in office Circular Nos. 4 and 48.


