Make use of school clinics as much as possible.

II. To do Supervision of the Hygiene and Sanitation of the School Plant.

A. To Assist in the Provision of the Health Equipment in School.

1. Handwashing facilities near the toilets and in the health corners, especially for grades I and II; near the lunch counter if there is any. To see that the proper type of washing facilities, the proper disposal of the waste water and the provision of soap are given attention.

2. Drinking facilities - To see that the type is sanitary, the source is safe, the carrying, the boiling, the keeping and the using are done satisfactorily as suggested in Guide in Health Education for Elementary Grades, pp. 51-54. There should be two waste containers, one for the used paper cups and the other for the waste water.

3. The toilets: That the type is good either squat or seat type. The boys' toilet should be provided with urinal tube, which may be made out of zinc or bamboo trough connected to the pit; the pits should be deep; the holes of the seat must be covered and they should comply with the standard measurement set by the Bureau of Education as suggested in the Guide, pp. 59-61.

4. Containers for waste in the classrooms and outside of the buildings should have covers.
