SUBJECT: Enlisted Men Unfit for Military Service
TO : CO. 3rd Bn., 66th Infantry, PA

1. The following EM in this Command found unfit for military service is hereby submitted:

- (a) Name..Martin Sangac, Rank..Private, Organization.. "M"
Co. 3rd Bn., 66th Infantry, PA.
- (b) Date of enlistment..December 14, 1942.
- (c) Date of physical examination..November 2, 1944.
- (d) Nature of disease, injury or deformity..Fracture, compound, lower 3rd, arm, right; Ankytosis, elbow joint (flexed position) right, secondary.
- (e) Degree of disability..Complete disability of right arm.
- (f) Line of duty..Yes. Pvt. Sangac, M. sustained the injury or deformity when the "M" Co. ambushed the Japanese garrison at Badayan Sawmill.
- (a) Name..Joseph Ignacio, Rank..Private, Organization.. "M"
Co. 3rd Bn., 66th Infantry, PA.
- (b) Date of enlistment...October 31, 1943.
- (c) Date of physical examination..October 23, 1945.
- (d) Nature of disease, injury or deformity..Eyeball, enucleated, complete, right.
- (e) Degree of disability...Complete disability of right eye.
- (f) Line of duty...No. The right eyeball was already removed before he entered the organization.
- (a) Name..Juan Siso, Rank...Private. Organization.. "M"
Co. 3rd Bn., 66th Infantry, PA.
- (b) Date of enlistment...October 28, 1942.
- (c) Date of physical examination...October 27, 1944.
- (d) Nature of disease, injury or deformity...Clawed hand, right. There is difficulty of raising the right hand.
- (e) Degree of disability...partial, but the lesion is progressive (becoming worst).
- (f) Line of duty...Yes. According to Lt. Rizal Geronilla, Pvt. Siso, was not like that when he was inducted into the service. He had been active in the service, but about four months ago his right wrist became swollen. He was examined by Dr. Salanga, on October 27, 1944 with the lesion already, but Dr. Salanga, most probably missed to detect the lesion. The lesion became progressive and on Jan. 5, 1944 he can't hold the rifle with his right hand because all his fingers of the right hand are all clawed. He could hardly raise his right hand.

- (a) Name...Sacyudan Ngiyao, Rank..Pvt., Organization.."I" Co., 3rd Bn. 66th Infantry, PA.
- (b) Date of enlistment...October 15, 1944.
- (c) Date of physical examination...December 13, 1944.
- (d) Nature of disease, injury or deformity..Dermatitis. generalized.
- (e) Degree of disability..Lesion is generalized throughout the body, arms, face, neck, and lower extremities.
- (f) Line of duty...No. According to Lt. Bacoling, A. and said enlisted man, Pvt. Ngiyao, S. had already the dermatological lesions before he was inducted into the service.

- (a) Name...Pucay Liwan, Rank..Pvt. Organization.."I" Co. 3rd Bn. 66th Infantry, PA.
- (b) Date of enlistment..February 1, 1944.
- (c) Date of physical examination...December 13, 1944.
- (d) Nature of disease, injury or deformity..Deafness, partial bilateral. There is difficulty to turn his head. There is also inability to open the mouth fully due to the rear tissue formed along the bullet wound that entered at about 1 cm. below the nuchal line and found its exit at the left cheek.
- (e) Degree of disability...partial.
- (f) Line of duty...Yes. (He sustained the injury or deformity when the "I" Co. had an encounter with the japs at Caban, Trinidad.

- (a) Name...Acas Colayong, Rank..Pvt., Organization "I" Co., 3rd Bn. 66th Infantry, PA.
- (b) Date of enlistment...January 3, 1943.
- (c) Date of physical examination...Not examined by any Bn. Surgeon.
- (d) Nature of disease, injury or deformity...P.B., Bone. This was the diagnosis given by the physician in charge at the hospital when said patient or man was admitted to the hospital at 1-66-113 (Hq. 114-M1) 1117) for treatment last August 22, 1944. Discharged unimproved.
- (e) Degree of disability...Complete. According to the P/As attached to "I" Co. and also Lt. Bacoling. This man can no longer walk.
- (f) Line of duty...According to the discharge slip, Pvt. Colayong contracted the disease in line of duty. (Capt. Jose P. Javier has the discharge slip in his file). According to Lt. Bacoling, Pvt. Colayong had been very active prior to August 22, 1944.



Note: Although the diagnosis given or made by the physician in charge of the hospital at 1..66..113 (Hq..114..NO..1117) is vague and incomplete, there is one important fact that should be taken into account to determine the status of Pvt. Colayong. The fact that

there is a n. of the bone (exact location is not mentioned in the diagnosis) implies a primary focus of the infection which is usually the lungs. This lesion will completely render him unfit for military service.


