EXECUTIVE ORDER  
No. 13, s. 1935

November 23, 1935

The following telegram from Hon. Jorge Vargas, Acting Secretary to the President of the Commonwealth and dated November 22, 1935 was received by this office:

"The President (of the Commonwealth) has today signed Proclamation declaring existence public calamity in your province."

JORGE VARGAS  
Secretary to the President."

WHEREAS according to the provisions of Act No. 4164, upon which is based the proclamation of the President of the Commonwealth, it is specifically prohibited for any person, firm or corporation in any locality where calamity is declared to exist, as a result of any typhon, earthquake or other act of God of similar nature; (1) To sell or offer for sale palay, rice, or corn, building or construction materials, any other prime necessities specified in such proclamation, at prices higher by 25% or more over and above the average current local price of such commodities one month previous to the occurrence of such public calamity as may be determined by the Director of Commerce; (2) To aggravate the crisis by refusing for the purpose of profiteering to sell at the legal price, or by hiding, concealing or hoarding the goods or commodities for the same purpose;

WHEREAS inasmuch as a public calamity is declared to have existed beginning November 22, 1935, it is hereby ordered that the provisions of the above mentioned law be strictly enforced by all Municipal Officials including the Police and the Constabulary and the violators thereof shall be duly arrested and brought under the pale of the law.

Sir:

I have the honor to request that an examination be made into the financial affairs and condition of "Gremio No. 35 - Los Defensores de la Libertad, Inc.," at Luna, that province.

The examination should cover the transactions had from April 1, 1931, the date next following that of the last examination, to the date as of which the examination herein requested shall have been conducted.

The report to be submitted by the examiner on the results of the examination should be patterned after the outline set forth under the heading, "Contents and Form of Report", which appears on pages 3 to 5 of the revised "Instructions on the Examination of Mutual Benefits, Relief, and Benevolent Societies or Association" which was promulgated by the Insular Treasurer on March 34, 1931. The balance sheet and statement of receipts and disbursements which will form part of the report should be drawn up as per models constituting Appendices "D" and "E" of our Circular No. 27. In other words, the different funds should be distinctly segregated. The statement of receipts and disbursements should be prepared following the distribution of income among the different funds provided for by the by-laws. Any discrepancy that may be found between the distribution of income shown in the books and that provided for by the by-laws, should be commented on in full. The cash on hand appearing in the balance sheet should be the cash on hand evolved in the statement of receipts and disbursements, if the book of the "Gremio" are kept by single entry; while the supluses of the various funds should be the difference between their respective total assets and total liabilities.

In case the books are kept by the double-entry method, where accounts receivable, accounts payable and other items which do not involve cash transactions are entered, the balances of the funds shown in the statement of income and expenses, plus inventories of the "Gremio's" property that have realization value, if any, should tally with the surpluses appearing in the balance sheet.

After the examination, the treasurer of the "Gremio" should, if it appears necessary, be given instruction on how to keep the books and other records of the organization and how to prepare the annual financial report and other reports which are called for in our circular No. 27.

Early attention hereto will be appreciated.
